# Witnesses to applicants signatures

The transfer must be executed as follows:

- For individuals, signatures must be witnessed by justice of the peace, a commissioner for declarations or for taking affidavits, a lawyer, a barrister, a solicitor or a notary public.
- For a corporation, the form is signed in accordance with the *Corporations Act 2001*, s127 by: either two directors, or a director and a company secretary, or the sole director who is the sole secretary.
- All applicants must be 18 years or over to hold an Authority.

Be aware that on registration of the transfer, all rights and liabilities attaching to the licence vest with the transferee.

#### Warning against increasing fishing effort

It is the responsibility of the transferee to ascertain whether the fishing authority being transferred may be used for the purposes intended and to seek advice on any **current investment warnings or management arrangements**, existing or proposed, that could affect the use of the fishing authority. ## **Company Extract**

A company extract is a specific document issued by the Australian Securities and Investment Commission which identifies the directors and secretaries of the company. Please note that a certificate of incorporation **is not a company extract**.

# **Transfer Duty (Previously Stamp Duty)**

Queensland Transfer Duty may be payable on the transfer of a fishing authority. Further details may be obtained from the Office of State Revenue on telephone 1300 300 734. The Commissioner of Stamp Duties may take action against either the vendor or purchaser when recovering unpaid duty.
