I, the Honourable Jackie Trad MP, Deputy Premier, Minister for Transport and Minister for Infrastructure and Planning, hereby notify under section 64(1) of the *Sustainable Planning Act 2009* (the Act) that the Yeerongpilly Transit Oriented Development (TOD) State Planning Regulatory Provision 2016 has been made on 3 May 2017 under chapter 2, part 6, division 2 of the Act.

I also notify under section 74(3) of the Act that the Yeerongpilly TOD State Planning Regulatory Provision 2014 is repealed with effect from 8 May 2017 under chapter 2, part 6, division 5 of the Act.

I have decided that, for schedule 6, Table 5 of the *Sustainable Planning Regulation 2009*, Brisbane City Council is the assessment manager for a development application that is made assessable under the Yeerongpilly TOD State Planning Regulatory Provision 2016, if the assessment manager is not otherwise specified under schedule 6 of the *Sustainable Planning Regulation 2009*.

“**Grantee’s Associates**” means the Grantee’s employees, contractors and other people authorised by the Grantee.

“**Grantor**” means the party named in Item 1 of the Form 9 of this document and its successors in title as registered owner of the Servient Tenement.

“**Servient Tenement**” means the land described in Item 2 of the Form 9 of this document.

“**Works**” means:

- (a) Open earth drains, underground pipes or mains for the purpose of conveying stormwater under or over the Servient Tenement together with all other usual necessary fittings and attachments; and

1.2 Headings

1.3 Construction

- (ii) A right includes a remedy, authority or power;

- (iv) The singular includes the plural and the plural includes the singular;

2. Operative Provisions

2.1 Purpose of Easement

The Grantor does hereby grant to the Grantee (at the Grantee's own risk and expense) the full and free right of using the servient tenement or any part thereof for drainage purposes in perpetuity as follows:

- (1) At all times to receive and convey upon the servient tenement stormwater runoff flowing continuously, intermittently or occasionally into, over or under and along the servient tenement from land adjoining the servient tenement and/or any other lands whatsoever and whether flowing naturally or by way of drains, pipelines or other artificial means.

- (4) The Grantee in exercising its rights herein shall take all reasonable steps to minimise damage to the servient tenement or any property of the Grantor thereon and subject to clause 2.3 shall promptly reinstate the servient tenement to a similar condition upon the completion of any such works or repairs by the Grantee.

 - (i) Construct and implement the Works (if applicable);
 - (ii) Remove and replace the Works with new Works;

- (vii) Do such Works and things on or under the Servient Tenement as are incidental to the exercise of the Grantee's rights under this Easement;
- (viii) Take down any fencing or structure erected on the Servient Tenement.

(2) In exercising its rights under this Easement, the Grantee and the Grantee's Associates will, subject to clause 2.3:

- (i) Exercise the rights in a proper and workmanlike manner so as to cause as little inconvenience and disruption as possible to the Grantor's land;
- (ii) Repair any damage it may cause to the surface of the Servient Tenement or adjoining land;
- (iii) Use the Servient Tenement at the risk of the Grantee and not at the risk of the Grantor.

2.3 Grantor's Obligations

- (1) The Grantor must not, without prior written consent of the Grantee:
 - (i) Construct or allow to be constructed upon the Servient Tenement any buildings or structures;
 - (ii) Permit the Servient Tenement to be used in such a way as to obstruct or interfere with the Works and/or proper and effective use of the Works by the Grantee;

 - (i) Will ensure that the building or structure is built in a proper and tradesman like manner in accordance with the plans submitted to the Grantee and will be maintained so as not to interfere with the Works;

- (ii) Acknowledges and accepts that the building or structure will be built upon the Servient Tenement at the sole risk of the Grantor and will be used and occupied at the sole risk of the Grantor;
- (iii) Acknowledges and accepts that it may be necessary for the Grantee to:
 - (a) demolish the whole or part of the said building or structure;
 - (b) carry out work under or upon the surface of the Servient Tenement which may have an adverse impact upon the said building or structure or interfere with the use and enjoyment of the said building or structure or the land;
- (iv) Acknowledges and accepts that it cannot make any claim for compensation whatsoever arising from the Grantee exercising its rights under this easement or at law;
- (v) The Grantee's consent to erection of the said building or structure on the Servient Tenement shall not be deemed in any way an assumption by the Grantee of any obligation towards the Grantor or to any person on the Servient Tenement and the Grantee shall not be thereby deemed to incur any liability.
- (vi) Indemnifies and will keep indemnified the Grantee against all actions, demands, claims, costs arising in any manner whatsoever from the construction, erection, use or occupation of the said building or structure upon the Servient Tenement.

2.4 Works in Property

- (iv) A party will not be liable for any loss, cost or expense of any other party caused or contributed to by the waiver, exercise, attempted exercise, failure to exercise or delay in the exercise of a right.

- (i) In any term or condition of this document or its application to any person or circumstances is or becomes invalid or unenforceable, the remaining terms and conditions shall not be affected thereby and each term and condition shall be valid and enforceable to the fullest extent permitted by law.
- (ii) If a provision contained in this Easement is invalid or unenforceable, that provision will, as far as possible, be read down to the extent necessary for it to be valid or enforceable but, if it cannot be read down, it will be severed from the document and the remaining provisions will remain in full force and effect.

4. Land Title Act

For the purpose of Division 4 (Easements) of the Land Title Act 1994:

- (i) The Grantee is a public utility provider; and
- (ii) This document is granted for the purpose of a public utility service.

5. Notices

- (i) Any notice under this Easement must be in writing; and
- (ii) Either party may serve a notice to the other party by:
 - (a) Giving it to that party personally;
 - (b) Posting it to the last known address of that party;

- 9.2 The policy must be written on a comprehensive basis with limits of not less than \$20 million per occurrence, or any higher limits that the Grantor may reasonably require from time to time.
- 9.3 The insurance policy required by this clause 9 must be taken out with an insurer authorised under the Insurance Act 1973 (Cth) and must name the Grantee as the insured.
- 9.4 The Grantee must provide a copy of the certificate of insurance or the insurance policy to the Grantor when requested.
- 9.5 The Grantee must notify the Grantor not less than 30 days prior to any material change in terms, cancellation or other termination of the policy.
- 9.6 If the insurance policy is cancelled, the Grantee must immediately take out another insurance policy on the same terms as specified in this clause 9.

10. Surrender of Easement

The Grantee may surrender this Easement at any time by giving the Grantor at least one month's notice.

If the Grantee gives a notice under this clause, the Grantee, at its cost, must prepare and execute a Form 10 Surrender of Easement and deliver it to the Grantor for execution and registration, prior to the expiry of the period specified in the notice given under this clause. Upon surrender of this Easement, the Grantee will not be entitled to claim any damages or compensation.

11. Power of Attorney

The Grantee irrevocably appoints the Grantor to be the attorney of the Grantee to:

- (a) execute on behalf of, in the name of and as the act and deed of the Grantee, a surrender of this Easement; and

- (b) do all such things and sign all such documents as may be necessary to obtain registration of the Form 10 Surrender of Easement.

“**Servient Tenement**” means the land described in Item 2 of the Form 9 of this document.

“**Works**” means:

- (a) pipes or mains for the purpose of conveying sewerage under or over the Servient Tenement together with all other usual and necessary fittings and attachments; and
- (b) Works for the protection and/or support of each of the things referred to in (a) above.

1.2 Headings

The clause headings appear in this document are inserted for convenience of reference and shall not affect the construction of this document.

1.3 Construction

Reference to:

- (i) A person includes:
 - (a) A corporation and governmental body; and
 - (b) The legal representative, successors and assigns of the person;
- (ii) A right includes a remedy, authority or power;
- (iii) A gender includes all genders;
- (iv) The singular includes the plural and the plural includes the singular;
- (v) Any Act includes all amendments or substitutions for the Act and the Regulations made under the Act.

2 Operative Provisions

2.1 Purpose of Easement

The Grantor does hereby grant to the Grantee (at the Grantee's own risk and expense) the full and free right of using the servient tenement or any part thereof for sewerage purposes in perpetuity as follows:

2.1.1 At all times to receive and convey upon the servient tenement sewage flowing continuously, intermittently or occasionally into, over or under and along the servient tenement from land adjoining the servient tenement and/or any other lands whatsoever and whether flowing naturally or by way of drains, pipelines or other artificial means.

2.1.2 To fill in the servient tenement or any part or parts thereof and to excavate therein and erect, construct and maintain above or below or partly above and partly below the surface of the land drains and/or pipelines and a sewer rising main and all appurtenances thereof for the passage or conveyance of sewage.

2.1.3 By itself or its officers, servants, agents, workmen with or without machinery, vehicles, plant and materials to enter into and upon the servient tenement at all reasonable times, upon giving prior written notice (except in the case of an emergency when no notice is required), for the purpose of removing and disposing of spoil, erecting, constructing, extending, deepening, widening, maintaining and repairing the said sewer rising main and/or pipelines and all appurtenance thereof and for the purpose of keeping the same in good order and condition and for all other lawful purposes incidental thereto.

2.1.4 The Grantee in exercising its rights herein shall take all reasonable steps to minimise damage to the servient tenement or any property of the Grantor thereon and subject to clause 2.3 shall promptly reinstate the servient tenement to a similar condition upon the completion of any such works or repairs by the Grantee.

2.2 Grantee's Rights

2.2.1 The Grantee (and Grantee's Associates) may at all reasonable times, upon giving prior written notice to the Grantor (except in the case of an emergency when no notice is required) with or without vehicles, machinery, plant and equipment and materials, to enter the servient tenement for the purpose of inspecting, servicing and maintaining the drains and pipelines on the servient tenement and in doing so may:

- (i) Construct and implement the Works (If applicable);
- (ii) Remove and replace the Works with new Works;
- (iii) Change the size and number of any pipes forming part of the Works;
- (iv) Extend, deepen, widen, repair, renew, mow, cleanse, add to, inspect and maintain the Works including altering, replacing, relaying or changing the size, shape or type;
- (v) Dig into, sink shafts into and open and break up the soil of the Servient Tenement;

(vi) Remove and dispose of soil created as a consequence of the Grantee exercising its rights under this Easement;

(vii) Do such Works and things on or under the Servient Tenement as are incidental to the exercise of the Grantee's rights under this Easement;

(viii) Take down any fencing or structure erected on the Servient Tenement.

2.2.2 In exercising its rights under this Easement, the Grantee and the Grantee's Associates will subject to clause 2.3:

- (i) Exercise the rights in a proper and workmanlike manner so as to cause as little inconvenience and disruption as possible to the Grantor's land;
- (ii) Repair any damage it may cause to the surface of the Servient Tenement or adjoining land;
- (iii) Use the Servient Tenement at the risk of the Grantee and not at the risk of the Grantor.

2.3 Grantor's Obligations

2.3.1 The Grantor must not, without prior written consent of the Grantee:

- (i) Construct or allow to be constructed upon the Servient Tenement any buildings or structures;

2.3.2 If the Grantor wishes to construct upon the Servient Tenement any building or structure, the Grantor must provide the Grantee with detailed plans enabling the Grantee to consider the request and the Grantee may in its absolute discretion refuse such request.

2.3.3 If the Grantee consents to the construction of a building or structure upon the Servient Tenement, the Grantor:

- (i) Will ensure that the building or structure is built in a proper and tradesman like manner in accordance with the plans submitted to the Grantee and will be maintained so as not to interfere with the Works;
- (ii) Acknowledges and accepts that the building or structure will be built upon the Servient Tenement at the sole risk of the Grantor and will be used and occupied at the sole risk of the Grantor;
- (iii) Acknowledges and accepts that it may be necessary for the Grantee to:

- (a) demolish the whole or part of the said building or structure;
- (b) carry out work under or upon the surface of the Servient Tenement which may have an adverse impact upon the said building or structure or interfere with the use and enjoyment of the said building or structure or the land;
- (iv) Acknowledges and accepts that it cannot make any claim for compensation whatsoever arising from the Grantee exercising its rights under this easement or at law;
- (v) The Grantee's consent to erection of the said building or structure on the Servient Tenement shall not be deemed in any way an assumption by the Grantee of any obligation towards the Grantor or to any person on the Servient Tenement and the Grantee shall not be thereby deemed to incur any liability.
- (vi) Indemnifies and will keep indemnified the Grantee against all actions, demands, claims, costs arising in any manner whatsoever from the construction, erection, use or occupation of the said building or structure upon the Servient Tenement.

2.4 Works in Property

- (i) The Works remain the property of the Grantee despite being fixed to the Servient Tenement.
- (ii) The Grantee is solely responsible for the maintenance of the Works.

2.5 Successor's in Title

The benefit and burden of the rights granted under this document shall pass with and bind the servient tenement so as it passes to and binds the Grantee and Grantor and their respective successors in title and is enforceable by and against the registered owners of the servient and dominant tenements respectively.

2.6 Maintenance

The Grantor shall maintain and keep the servient tenement in a reasonably neat and tidy condition at all times.
