- Provision of a copy of the current company extract (see notes) for each company involved in the above transfer. You may provide a copy with your application, or a copy can be arranged on your behalf by contacting this office (fees apply).

**Witnesses to applicants signatures**

The transfer must be executed as follows:

- For individuals, signatures can be witnessed by any other person, the witness must be 18 years or over.
- For a corporation, the form is signed in accordance with the *Corporations Act 2001*, s127 by: either two directors, or a director and a company secretary, or the sole director who is the sole secretary.
- Be aware that on registration of the transfer, all rights and liabilities attaching to the quota vest with the transferee.
- All applicants must be 18 years or over to hold an Authority.

**Company Extract**

A company extract is a specific document issued by the Australian Securities and Investment Commission which identifies the directors and secretaries of the company. Please note that a certificate of incorporation is **not a company extract**.

**Transfer Duty (Previously Stamp Duty)**

**Queensland Transfer Duty** may be payable on the registration of this transfer. Further details may be obtained from the Office of State Revenue on telephone 1300 300 734. The Commissioner of Stamp Duties may take action against either the vendor or purchaser when recovering unpaid duty.
