

Guidelines



The **Regional Networker Grants** program is administered by the Department of Employment, Small Business and Training (DESBT). The program assists Chambers of Commerce, Small Business and Industry Associations and eligible Councils to generate:

- stronger networks for small businesses across regional Queensland.
- a lasting impact on the relevant local small business community and the level of collaboration involved.

### **Program outcomes**

The expected outcome of the grants program is to generate and help foster stronger collaborative networks for small businesses across regional Queensland.

This must be able to be demonstrated through a post grant report on how the grant funded activity has created connections for local small businesses.

# **Available funding**

Grant funding (excluding GST) is paid up-front on approval.

Successful applicants do not need to contribute towards the total project cost. However, they are responsible for covering any additional expenses beyond the \$2,000 of grant funding (excluding GST).



DESBT will not fund grant funded activities with:

- ★ A total cost of less than \$2,000 (excluding GST)
- Payments made on grant-funded activity before grant approval.

## Eligibility criteria

To be eligible to apply for this grant, the applicant must (at the time of applying):

- ✓ have an active Australian Business Number (ABN)
- be based in Queensland and:
  - o located in a regional or remote area or
  - o propose to run the grant funded activity in an eligible area
- ✓ be a small business association/group, Chamber of Commerce, industry association or local regional council
- ✓ have owners/directors that are not undischarged bankrupt and be solvent

the authorised contact must:

✓ have authority to apply on behalf of the applicant organisation

Organisations (or venue location) are required to be in a local government area **outside of the following ineligible local government areas**:

★ Brisbane
★ Cold Coast
★ Dadler

★ Gold Coast
★ Redlands

★ Ipswich

★ Sunshine Coast

★ Sunshine Coa

# **Eligible activities**

DESBT will fund eligible grant funded activities that:

- creates new or builds on existing networks to support local small business owners to connect and collaborate.
- ✓ is delivered in May 2024 as part of the Queensland Small Business Month Program.
- ✓ if used for an event, the event must be published in the <u>Business Queensland Event</u>
  Calendar
- ✓ uses the Regional Networker Grant and QSBM branding

# Ineligible activities (we will not fund)

DESBT will not fund:

- x marketing costs for existing businesses
- **X** equipment for businesses
- x payment of rates/bills for businesses
- x alcohol charges as part of project catering.

DESBT <u>will not fund</u> goods, services or fees from related parties. **Related** parties include companies that have common shareholdings or directors, as well as employees or immediate family members.

### **Application process**

Applying is completely free via the DESBT SmartyGrants portal once the grant round opens on 22 February 2024. The grant will close on 5pm, 14 March 2024.

### Submit an application

In the application you will be asked to provide:

- essential business details to confirm eligibility (including evidence of eligible locations)
- authorised contact details
- proposed grant funded activity details including venue location, description, start and end date/times, target audience, estimated number of attendees, event categories
- expected outcomes
- · anticipated costs

#### **Assessment**

Applications are assessed for compliance against the eligibility criteria within these guidelines and their competitiveness with program guidelines and assessment criteria.

Applicants must demonstrate the extent to which the grant funded activity will:

- positively impact and connect regional small business communities
- lead to ongoing links and networks beyond QSBM2024
- value for money

#### Notification of outcome

DESBT will advise applicants of the outcome of their grant application in early April 2024 via the email address submitted with their application.

### Funding agreement and payment

Grant recipients enter into a funding agreement with DESBT to receive funding of \$2,000 (excluding GST). Funding is paid as soon as practical after approval.

The funding agreement consists of:

- 1. the Letter of Agreement
- 2. any other terms agreed in writing between the parties
- 3. the Terms and Use
- 4. these Guidelines and
- 5. the **application** submitted by the applicant for the grant activity.

#### Recipient completed activities

Recipients must:

- **start** their grant funded activity immediately to ensure activity is occurring in Queensland Small Business Month (May 2024).
- advise DESBT if you need to make changes to your approved grant.
- **promote** their grant funded activity in their local community (see Promotion below).
- **complete** an acquittal report (see Acquittal report below).

#### **Promotion**

Recipients must promote their project to their local community:

- using the supplied QSBM2024 branded templates and Acknowledgement Statement
- uploading their project to the Business Queensland Event Calendar
- completing the good news story template and providing back to <a href="mailto:events@desbt.qld.gov.au">events@desbt.qld.gov.au</a>

### **Acquittal report**

Recipients must submit an acquittal report after completing their grant funded activity. The acquittal report requires the following:

- details of the grant funded activity deliverables
- detail the project implementation and impact on the business, including the results and outcomes achieved through the project and
- evidence of deliverables and payments including supplier quotes, corresponding invoices, receipts, bank transactions and outputs to show the project activities were delivered.
