### CUNNINGHAM HIGHWAY (17A) (Ipswich Motorway) IPSWICH CITY COUNCIL

Commencing from its junction with the Logan Motorway near the most northern point of Lot 2 on CP816832 in Carole Park, travelling in a general westerly direction to its junction with the Warrego Highway in Riverview.

Length: 7.7 kilometres (approximately)

The parts of the road to which access is to be limited are shown on plans LA12232, LA12233, LA12234, LA12235 and LA12236. Copies of the Limited Access (LA) plans are held in the Metropolitan Regional Office of the Department of Transport and Main Roads at 313 Adelaide Street, Brisbane City QLD 4000.

The reason for the declaration is to:

- (1) Ensure that the arterial and motorway function of the Road is preserved.
- (2) Maintain an appropriate road hierarchy with the surrounding road network.

- (3) Maximise the Road's traffic carrying capacity and safety characteristics.
- (4) Ensure an ongoing high level of access to service the region and as a connection to the arterial network.

Any person whose interests are affected by the declaration may:

- (1) Under section 485 of the *Transport Infrastructure Act 1994* ask for the decision to make the declaration to be reviewed by the Chief Executive.
- (2) Under the *Transport Planning and Coordination Act 1994*, part 5, division 2 apply for the original decision to be stayed.
- (3) Under the Transport Planning and Coordination Act 1994, part 5, division 3
  - (a) appeal against the Chief Executive's decision on the review to the court stated in Schedule 3 of the *Transport Infrastructure Act 1994* for the decision; and
  - (b) apply for the reviewed decision to be stayed.

Notice is hereby given that there is a policy in place in relation to the application of s62 of the *Transport Infrastructure Act 1994* to access between the Cunningham Highway (Ipswich Motorway) (17A) and adjacent land. The policy is set out below.

#### POLICY FOR CUNNINGHAM HIGHWAY (Ipswich Motorway) (17A)

### 1. PURPOSE

The purpose of this policy is to protect the function, safety and efficiency of the Cunningham Highway (Ipswich Motorway) (17A) ("**Road**") by setting out the principles that will be applied when making decisions relating to vehicular access under s62 of the *Transport Infrastructure Act 1994*.

In this respect, the management of access is essential to:

- (1) Ensure that the motorway and arterial function of the Road is preserved.
- (2) Maintain an appropriate road hierarchy with the surrounding road network.
- (3) Maximise the Road's traffic carrying capacity and safety characteristics.
- (4) Ensure an ongoing high level of access to service the surrounding areas.
- (5) Ensure surrounding land uses and activity centres remain accessible.
- (6) Cater for planned increases in the surrounding land use and the anticipated growth in traffic volumes, public transport services and active transport trips.
- (7) Ensure vulnerable road uses such as cyclists and pedestrians are catered for in line with government policy.
- (8) Ensure that future growth and changing land use does not adversely impact on the Road's arterial function and its connection to the wider road network.

Not permitting any additional direct access to the Road is essential to achieve the road vision.

#### 2. HEAD OF POWER

This policy has been made pursuant to s54 of the Transport Infrastructure Act 1994.

#### 3. ROAD VISION

The following vision for the Road sets the context within which the policy principles (section 5) and the policy strategies (section 6) will be applied.

The Road incorporates the Ipswich Motorway declared as a Motorway on the 28<sup>th</sup> July 1995. The Road is a key component of the State-controlled Road network which connects to the Cunningham Highway (17B), Warrego Highway (U15A), Cunningham Arterial Road (Ipswich Motorway) (U16) and the arterial network. The Road is a main traffic corridor between Brisbane and Ipswich carrying commuter and commercial traffic, inter-regional and interstate traffic into and out of Brisbane.

All direct access between adjoining properties and the Road have been removed as part of the upgrade of the Road to Motorway status. Local vehicular access is provided via a system of service road and local government intersections on either side of the Road with all access to and from the Road via controlled grade separated interchanges.

The vision for the Road is that it continues as a key arterial road for freight, commuter and general traffic movement and part of the national road network and a strategic link to the national key freight route.

The Road will continue to grow as an important arterial link into the future performing as a vital general and freight transport corridor.

The Road is facing pressure from increasing residential, industrial and commercial development on both sides of the road as the surrounding suburbs expand and intensify. For example, the urban growth in Ipswich Principal Activity Centre, Southwest Brisbane, Springfield and Redbank Plains. Freight and traffic volumes are forecast to increase. In the future, general capacity will need to be accommodated at key intersections and connections to accommodate future travel demands, growing traffic volumes, level of service and the need for safety and reliability of driving conditions. The purpose and vision of this Limited Access Policy is to preserve the Road's efficiency and its motorway and arterial function. The Department of Transport and Main Roads anticipates the need for improvements to connections to the Motorway and arterial network and for enhanced public and active transport.

Therefore, this Limited Access Policy for the Road does not permit any direct Access to the Road. All access to the Road is to be via the existing system of service road intersections and controlled grade separated interchanges.

The Road infrastructure has been constructed to prevent access.

#### 4. APPLICATION

This policy will be applied in assessing applications made under s62 or s62A of the *Transport Infrastructure Act 1994*.

This policy will also be applied in:

- (1) The preparation, amendment or review of local, state, and federal government planning schemes and other planning instruments to ensure that:
  - (a) land uses reflect the policy principles and policy strategies and preserve the function of the Road:

- (b) the local road network is developed to provide access to land where access from the Road is not supported;
- (c) the vision for the Road identified in section 3 is accommodated;
- (2) General transport planning relevant to managing access to limited access roads.
- (3) When assessing development applications made pursuant to the Planning Act for impacts on the Road.

#### 5. POLICY PRINCIPLES

When making a decision relating to the management of access between land and the Road, the following principles will be applied:

- Access must not compromise safety of the users of the Road or any other transport infrastructure.
- (2) Access must be consistent with the functional requirements of the Road.
- (3) Access must be consistent with the current or planned intent for the Road corridor and the wider State-controlled road network.

In applying the principles, regard will be had to the following strategies:

- (1) The strategies applying to vehicular access to State-controlled roads set out in the *Vehicular access to state-controlled roads policy*<sup>1</sup>.
- (2) The policy strategies set out in section 6.

Where there is inconsistency between the strategies set out in the *Vehicular access to state-controlled roads policy* and the policy strategies set out in this policy, the policy strategies set out in this policy prevail.

#### 6. POLICY STRATEGIES

### **SAFETY**

Principle 1: vehicular access must not compromise safety of the users of the Road or any other transport infrastructure

Safety is paramount. Given the high-speed, high volume road environment and form and function of the Road, new direct access to the Road will not be permitted.

# Strategy 1 No additional access locations for properties adjoining the Road will be permitted.

There are no direct property accesses onto the Road. To ensure the ongoing safety of road users, no new road access will be permitted.

## **FUNCTION**

Principle 2: Vehicular access must be consistent with the functional requirements of the Road

The primary function of the Road is as an arterial route or motorway. To preserve this function, all direct access to the Road have been removed as the Road was progressively upgraded to a Motorway. Access to the Road is provided via a system of service roads on either side of the road and at controlled grade separated interchanges.

# Strategy 1 No additional access locations for properties adjoining the Road will be permitted.

There are no direct property accesses onto the Road. To preserve the existing function of the Road as a Motorway, no new road access locations will be permitted.

### **FUTURE INTENT**

Principle 3: Vehicular access must be consistent with the current or planned intent for the wider network

The Department of Transport and Main Roads anticipates that additional capacity will need to be provided in the future to accommodate growing traffic volumes, road efficiency, level of service and the need for safety.

# Strategy 1 No additional vehicular access locations for properties adjoining the Road will be permitted.

There are no direct property accesses onto the Road. To maintain the existing safety levels along the Road, no new road access will be permitted.

#### 7. **APPROVAL**

This policy applies to the Road and will be applied when making decisions under s62 of the *Transport Infrastructure Act 1994*.

#### 8. ADDITIONAL INFORMATION

This policy may be amended at any time without notice if:

- (1) The amendment merely changes or repeals a specific provision for 1 or more properties.
- (2) The owner or occupier of each property has been given written notice of the amendment.

Under s61 of the *Transport Infrastructure Act 1994*, a person must not construct or change a physical means of entry or exit for traffic between land and a limited access road without first obtaining a decision under s62(1) that authorises the construction or change. Maximum penalty – 200 penalty units.
