IN pursuance of the powers and authorities in me vested under the provisions of "The State Forests and National Parks Acts, 1906 to 1941," and in pursuance of all other powers and authorities in me vested, I, Sir LESLIE ORME WILSON, the Governor aforesaid, with the advice of the Executive Council, do, by this my Proclamation, notify and proclaim that the land described in the Schedule hereunder shall be and is hereby permanently reserved and declared to be a State Forest.

28. (a) Every survey whether urban, suburban, or country shall be referred by bearings and distances to iron pins not less than 12 inches in length by $\frac{5}{8}$ inch in diameter and such bearings and distances shall be recorded in the field notes and shown on the plan.
