The Marine Danger Area will be closed for access from 0001 hours Monday, 21 April 2025 to 2359 hours Wednesday, 23 April 2025. All waters, creeks, beaches and other areas within the declared Marine Danger Area are not available for access throughout the above times.

Pursuant to section 53 of the *Defence Force Regulation 1952*, any person or vessel found within the Marine Danger Area of the Gazetted Defence Practice Area commits an offence subject to 5 penalty units or imprisonment for 3 months, or both.

Pursuant to section 54 of the *Defence Force Regulation 1952*, such persons or vessels may be removed by Australian Defence Force personnel, or by the Queensland Police. Any costs associated with removal may be borne by the owner, hirer, charterer or agent of the watercraft.

A new Defence Practice Area – Shoalwater Bay has been implemented by the Minister of Defence as of 5 February 2007. The Defence Practice Area has been expanded and may be inconsistent with the area currently represented on some available marine charts and land maps.
