# Statutory transfer or cancellation of registered training contracts

# Purpose

This procedure details the steps to be taken under the *Further Education and Training Act 2014* (FET Act) if a business is sold or a partnership is dissolved and apprentices/trainees employed within the business will be affected.

# Overview

An employer of an apprentice/trainee is to give the Apprentice Connect Australia Provider Provider), the Department, or the Racing Queensland Board (RQB) (for specified racing industry occupations), a signed notice if the employer sells or disposes of their business, or a partnership dissolves.

If a business is sold, the new owner (purchaser) continues to train the apprentices/trainees under their registered training contracts unless the new owner provides contrary written advice to the Provider, the Department or the RQB prior to the sale taking effect.

If a business partnership dissolves, the remaining partner/s will continue to train the apprentices/trainees under their registered training contracts. If there are no remaining partners, the contract/s is/are taken to be cancelled.

These actions relate to the registered training contract and have no impact on any continuing employment obligations that may be applicable.

Note – where a business which employs an apprentice/trainee has changed its legal name and/or ABN, or changed the name of the trust/s or trustee/s, but these changes are NOT due to the sale or disposal of the business or a partnership being dissolved, the employer should notify the Provider, the Department or the RQB using the <u>ATF-046 Amendment – change of legal name or change of legal name and ABN</u> form.

# Process

**Note** – training contracts in several racing industry occupations are managed by the Racing Queensland Board (RQB). Refer to the section below titled 'Definitions' for training contracts where the RQB exercises regulatory powers and functions under the FET Act.

#### Employer:

- If a business partnership dissolves, provide signed notice within 14 calendar days to the Provider, the Department, or the RQB (for specified racing industry occupations), identifying the date of effect and advising details of the partner/s (if any) who will continue the business, or advising that the business will not be continued by any of the partners. Where the business is not continued by any of the partners, the registered training contracts are taken to be cancelled.
- If selling or disposing of a business, provide signed notice of this event within 14 calendar days after the sale or disposal, to the Provider, the Department or the RQB, identifying the date of effect.

Form <u>ATF-041 Notification of change of ownership/statutory transfer (sale of business)</u> is available to assist the employer provide signed notice.

#### Supervising Registered Training Organisation (SRTO):

• Develop a new training plan and have it signed within 28 calendar days after the transfer of the training contract.



#### Sale/disposal of business where purchaser is continuing the training contract

#### Purchaser of business:

• If purchasing a business and agreeing to continue training the apprentices/trainees of the business under their registered training contracts, provide signed notice of this agreement within 14 calendar days after the purchase, to the Provider, the Department, or the RQB (for specified racing industry occupations).

Form <u>ATF-041 Notification of change of ownership/statutory transfer (sale of business)</u> is available to assist the purchaser provide signed notice.

# Delegated Officer – Apprentice Connect Australia Provider (Provider), Training and Skills, or Racing Queensland Board (RQB) for specified racing industry occupations):

- Provider or the Department Transfer the registered training contract to the purchaser the date of effect is the date of sale or disposal of the business.
- RQB Send correspondence to the parties using the letter template 'Statutory transfer'.
  - Provide details on a Format of Advice form, including the date of effect (being the date of sale or disposal of the business), and upload it, together with associated documentation, to the Department via SharePoint.

#### Metro regional office, Training and Skills:

• Upon receipt of a Format of Advice and associated documentation from the Racing Queensland Board advising of the sale/disposal of a business where the purchaser is continuing a registered training contract(s), update the training contract details in DELTA accordingly and save the associated documentation in CEDRIC.

#### Sale/disposal of business where purchaser is not continuing the training contract

#### Purchaser of business:

If purchasing a business and deciding not to continue training the apprentices/trainees of the business
under their registered training contracts (i.e. the purchaser does not want the training contracts transferred
to them), provide written notice of this fact to the Provider, the Department, or the RQB (for specified racing
industry training contracts), <u>before</u> the purchase takes effect (note – if written notice is not received before
the purchase takes effect, all registered training contracts will be transferred to the new purchaser).

Form <u>ATF-041 Notification of change of ownership/statutory transfer (sale of business)</u> is available to assist the purchaser provide signed notice.

# Delegated officer – Apprentice Connect Australia Provider (Provider), Training and Skills, or Racing Queensland Board (RQB) (for specified racing industry occupations):

- <u>Provider or the Department</u> Apply the relevant steps, according to the date on which notification of the sale or disposal of the business was received:
  - o Notification received before the sale or disposal of the business took effect:
  - cancel the training contract/s with a termination date as per the advice provided.
  - Notification received after the sale or disposal took effect:
    - transfer the registered training contract to the purchaser with a date of effect as per the date of sale or disposal taking effect.
    - the parties may subsequently pursue transfer of the training contract to another employer, or <u>cancellation</u>.
- <u>RQB</u> Send correspondence to the parties using the letter template 'Statutory transfer cancel due to opt out'.
  - Provide details on a Format of Advice form and upload it, together with associated documentation, to the Department via SharePoint.
  - Note if notification was received after the sale or disposal took effect, transfer the registered training contract to the purchaser with a date of effect as per the date of sale or disposal taking effect. The parties may subsequently pursue transfer of the training contract to another employer, or cancellation.



#### Metro regional office, Training and Skills:

• Upon receipt of a Format of Advice and associated documentation from the Racing Queensland Board advising of the sale/disposal of a business where the purchaser is not continuing a registered training contract(s), update the training contract details in DELTA accordingly and save the associated documentation in CEDRIC.

#### Dissolving partnership where none of the partners continue the business

#### Delegated officer – Apprentice Connect Australia Provider (Provider) or Training and Skills:

- Cancel the training contract/s, with a termination date as per the employer's notification.
- Provide written notice of the cancellation to the apprentices/trainees (note the Department will provide the written notice irrespective of whether the Provider or the Department cancels the training contracts).

#### Delegated officer – Racing Queensland Board (RQB) (for specified racing industry occupations):

- Send correspondence to the parties, using the letter template 'Statutory transfer cancel due to dissolution of partnership s29'.
- Provide details on a Format of Advice form, to cancel the training contract/s with a termination date as per the employer's notification, and upload it together with associated documentation, to the Department via SharePoint.

#### Metro regional office, Training and Skills:

• Upon receipt of a Format of Advice and associated documentation from the Racing Queensland Board advising of the of the dissolving of a business partnership where none of the partners are continuing the business and a training contract is consequently cancelled, update the training contract details in DELTA accordingly and save the associated documentation in CEDRIC.
