Instructions

Applications must be lodged with Brisbane office within 6 months of the date of movement.

To be eligible for freight subsidy, the charity organisation must be registered with the Australian Charities and Not-for-profits Commission.

Tax invoices for the purchase (if applicable) and freight of each consignment must be included.

- 2. I understand that the payment of Drought Relief Assistance Scheme freight subsidies for the transport of donated fodder is conditional upon the satisfactory completion of sections B and C of this form.
- 3. The distance travelled was the shortest practical route.
- 4. When a hired carrier was used, all transport costs have been paid and tax invoices and other documents covering the consignments are attached.
- 5. All fodder carted was donated to the charity or **where fodder has been purchased** by the charity with donated funds, the applicable **purchase tax invoices** for the fodder have been attached.
- 6. I understand that any applications submitted under the Drought Relief Assistance Scheme may be subject to audit by DAF or its agents in order to determine compliance with scheme guidelines. By signing this declaration, I understand that I may be asked to provide further information in regards to this application as part of an audit process to determine compliance with scheme guidelines.
- 7. The information I have provided in this application and in supporting documentation is, to the best of my knowledge, true and accurate. I understand that providing inaccurate, untrue or misleading information may be a breach of criminal law, for which serious penalties may apply. I also understand that in any information I have provided in the application or supporting documentation is found to be inaccurate, untrue or misleading, legal action may be taken against me, including action to recover the subsidy.
