



## Terms and conditions

Read the terms and conditions applying to the Forget the bet Brisbane Heat jersey Competition.

- 1. These terms and conditions set out all of the information regarding the Forget the bet Brisbane Heat jersey Competition (the **Terms and Conditions**).
- 2. The Promoter of this Competition is the Department of Justice and Attorney-General, Brisbane, Queensland 4000, ABN 13 846 673 994 (the **Promoter**).
- 3. Information on how to enter this Competition forms part of these Terms and Conditions.
- 4. Competition entry is deemed acceptance of these Terms and Conditions.
- 5. **Prize:** There is one (1) prize available, consisting of one (1) signed Brisbane Heat BBL jersey (the **Prize**) valued at \$550.00.

The Prize is not exchangeable or transferable and cannot be redeemed for cash. Any additional expenses incurred by the Prize winner in connection with the Competition, other than those outlined in these Terms and Conditions, are the responsibility of the Prize winner.

The Prize is to be used for the benefit of the participating club. It is not intended that the Prize be used for the personal benefit of the entrant president or committee member or otherwise in any personal capacity.

6. **The competition period:** This competition will open at 9:00am AEST Wednesday 27 March 2024 and close at 4:00pm AEST Thursday 6 June 2024.

Entries will only be accepted during this time.

## 7. How to enter:

To enter the Competition, entrants must register as a Forget the bet supporters club online at <a href="https://www.qld.gov.au/forgetthebet">www.qld.gov.au/forgetthebet</a> and answer 'Yes' to the question 'Would you like your club to enter the competition?'.

Only one entry per club, will be accepted. Any subsequent entries (even if from separate individuals) from the same club will be deemed invalid.

- 8. **Eligibility:** To be eligible to enter this competition, a person must:
  - (a) not be an employee or contracted staff of the Promoter; and
  - (b) be the **president or a committee member** of the participating Queensland club.

- 9. Competition Draw: The Prize winner will be the first valid entry drawn at random by an officer of the Promoter from the pool of eligible entrants. No eligible entrants will be eliminated prior to the Competition Draw. The drawing of the Prizes will take place on Tuesday 11 June 2024. The prize winner is not required to be present at the time of the draw.
- 10. **Winner Notification:** The Prize winner will be notified by email or phone call at the contact details supplied by the entrant when registering as a Forget the bet supporter, by an officer of the Promoter by 5:00pm AEST on Tuesday 11 June 2024.
- 11. **Winner Publication:** The name of the Prize winner will be published on the Forget the bet website www.qld.gov.au/forgetthebet.
- 12. **Prize delivery:** The Prize will be delivered to the address of the winning club or to an alternate address as agreed between the Promoter and the Prize winner.
- 13. **Re-Draw**: In the event that the Prize winner cannot be contacted within 7 working days of the draw on Tuesday 11 June 2024, the person's right to the prize is forfeited and the prize will be treated as an unclaimed prize. A replacement Prize winner will be drawn at random by an officer of the Promoter from the remaining pool of eligible entrants.
- 14. The Promoter will not be liable for any loss, expense, damage or injury sustained by any entrant in connection with the Competition, the Prize or redemption of the Prize, except for liability which cannot be excluded by law.
- 15. The competition will be governed by the laws of Queensland.
- 16. Important Privacy Consent: By entering this competition, the entrant acknowledges and consents to their personal information, including their name, email and phone number being collected and stored on the Promoter's database for the purpose of this competition and administration of the Forget the bet, enjoy the game Queensland community sports clubs' program.
- 17. The Promoter reserves the right to modify these Terms and Conditions at any time and to cancel or amend the competition at any time without notice or further recourse to the entrants.
