- 1. Tuesday, the first day of October, 2024 to be the day of issue of this Writ.
- 2. Saturday, the fifth day of October, 2024 to be the cut-off day for electoral rolls for the election.
- 3. Tuesday, the eighth day of October, 2024 to be the cut-off day for the nomination of candidates for the election.
- 4. Saturday, the twenty-sixth day of October, 2024 to be the polling day.
- 5. Wednesday, the fourth day of December, 2024 for the return of this Writ to the Governor of our State of Queensland at Brisbane.


