



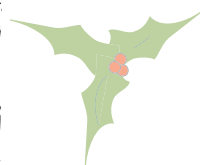

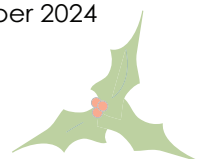

1. Cairns Regional Council (**Council**) hereby declares that the easements described in Schedule 2 are taken by the Council for public thoroughfare (shared pedestrian and bikeway) purposes on and from the date of publication of this notice in the Gazette in accordance with ss 15B and 15D of the *Acquisition of Land Act 1967*.

**Rights and obligations**

2. The rights and obligations conferred and imposed by each easement include the matters set out in Schedule 1.

**SCHEDULE 1**

The Council holds an easement for the purposes, powers, rights and liberties set out below:

**1. GRANT OF EASEMENT FOR PUBLIC THOROUGHFARE**

Subject to the terms of this document the Council has the full, free and uninterrupted right and liberty at all times of the day and the night and from time to time at the Council's pleasure:

- (a) to allow members of the public to enter upon and traverse the Servient Tenement for pedestrian access and by cyclists; and
- (b) to bring vehicles reasonably necessary for the building and maintenance of the Public Thoroughfare Easement including to carry out such works on the Servient Tenement and do such things including, without limiting the generality of the foregoing, digging, opening and breaking up the soil both surface and subsurface, placing and operating machinery and equipment, storing soil and gravel, digging trenches and laying concrete on or within the Servient Tenement as the Council in its absolute discretion considers necessary or desirable for any purpose whatsoever connected with the building and maintenance of the Public Thoroughfare Easement for pedestrian access and cyclists; and
- (c) do such other works and things through, across or in the Servient Tenement which are incidental to the proper exercise of the rights granted to the Grantee by this Easement.

**2. GRANT OF EASEMENT**

- (a) The rights granted under this Easement:
  - (i) are not exclusive to the Council and are subject to the rights of the Owner and other persons lawfully entitled to use the Servient Tenement from time to time; and
  - (ii) subject to the provisions of the Act may be exercised over the whole or any part of the Servient Tenement in any manner and by any means the Council shall determine.
- (b) The Owner accepts that for safe and orderly access or right of way over the surface of the Servient Tenement the Council shall be entitled to control the use of the Servient Tenement by members of the public and for such purpose Council shall be entitled to:
  - (i) install such structures by way of signage, railing, barriers or any other means upon the Servient Tenement and for this purpose is entitled to use the subsurface of the Servient Tenement; and
  - (ii) issue such requirements as to the use of the Servient Tenement including restrictions on the Owner as is reasonably required to ensure compliance with any restrictions placed on the use of the Servient Tenement.

**3. PUBLIC INCLUDED**

Subject to any restrictions imposed by the Council under Clause 2 the Council authorises members of the public to use the Servient Tenement as pedestrians and cyclists.

**4. COUNCIL'S AGENTS AND EQUIPMENT**

- (a) Council in exercising any of the powers, rights and liberties conferred by this document may do so by itself or by any one or more of Council's Agents.
- (b) Council or Council's Agents whether by themselves or in conjunction with others may exercise any one or more of the powers, rights and liberties conferred on the Council by this document on Council and if necessary with vehicles, machinery and equipment of any description whatsoever.

**5. OWNER NOT TO OBSTRUCT EASEMENT**

The Owner must not at any time without the prior written consent of the Council:

- (a) execute or construct any excavations drains channels roads or other works of any kind in the Servient Tenement;
- (b) remove or interfere with any existing Council Works within the Servient Tenement;

- (c) erect any buildings or structures under, on or over the surface of the Servient Tenement or any part thereof;
- (d) install concrete, bitumen or other pavement or driveways in the Servient Tenement or gardens or landscaping of any kind;
- (e) stockpile or permit the stockpiling of any soil, sand, gravel or other substance or material in or immediately adjacent to the Servient Tenement which would in any way obstruct or interfere with the effective use thereof by the Council as a Public Thoroughfare Easement.

6. **WORKS PROPERTY OF COUNCIL**

All Council Works are and remain the property of the Council notwithstanding any actual or apparent affixation to the Servient Tenement.

7. **OWNER NOT REQUIRED TO MAINTAIN**

The Owner is not required to maintain or contribute to the maintenance of any part of the Servient Tenement utilised as a Public Thoroughfare Easement.

8. **COUNCIL NOT LIABLE TO FENCE**

The Council is not required to fence or contribute to the fencing of any part or parts of the boundaries of the Servient Tenement.

9. **OWNER NOT LIABLE**

The Owner is not liable for any act done, or omission made, honestly and without negligence in relation to the Servient Tenement.

10. **OWNER TO COMPLY WITH CONDITIONS OF DEVELOPMENT PERMIT**

The Owner acknowledges that nothing in this Easement relieves the Owner of the obligation of complying with the conditions of any Development Permit relating to the Owner's Land except to the extent varied by this Easement.

11. **FURTHER RIGHTS OF COUNCIL**

The Council shall:

- (a) be at liberty to take up and remove the whole or any part of any Council Works at any time during the continuance of this Easement or within six months of the determination of the Easement;
- (b) in the event a building or structure or other material or thing is erected, placed, found or installed upon the Servient Tenement in contravention of Clause 5, in addition to any other remedies and after having first given the Owner reasonable notice of its intention to invoke this clause, be at liberty to enter upon the Servient Tenement and remove or demolish the relevant material and, if it does so:
  - (i) the Council may dispose of the relevant material or any resultant demolition material in such manner as it deems fit without being liable to account to the Owner; and
  - (ii) the Council may recover, in any Court of competent jurisdiction, costs actually incurred by it in taking that action (including internal wage and salary costs) less any money actually received by it as a result of disposing of the relevant material or any resultant demolition materials.

12. **COUNCIL'S STATUTORY RIGHTS**

Nothing herein expressed or implied shall limit or destroy any right or privilege of the Council to at any time purchase take by agreement resume or otherwise acquire the whole or any part of the Servient Tenement.

13. **NO WAIVER**

No term, covenant, condition or restriction herein expressed or implied will be deemed to have been waived by the Council either in whole or in part unless such waiver is in writing. Any such waiver will not affect or prejudice the rights or remedies of the Council in respect of any future or other breach and (unless expressly so stated) will not amount to a general waiver of any provision hereof.

14. **COSTS**

The costs of preparation of the easement survey plan and preparation, stamping and registration of this Easement will be paid by the Council.

15. **GENERAL**

- (a) Neither party is released from any liability arising from any breach under this Easement if that party ceases to be the registered owner of the whole or any part of the Servient Tenement.
- (b) If requested by the other, each party must execute all documents and do all things necessary to further assure to the Council the rights intended to be conferred on the Council by this Easement.



16. **DEFINITIONS AND INTERPRETATION**

Unless the contrary intention appears:

“Act” means the *Land Title Act 1994*;

“Council” means Cairns Regional Council as Grantee and its successors, transferees and assigns;

“Council Works” means works of any kind necessary or desirable for the construction, maintenance and repair of the Public Thoroughfare;

“Council’s Agents” includes the employees, agents, licensees and contractors of the Council;

“Easement” shall mean this Easement and includes all annexures thereto;

“Owner” shall mean and include the registered owner of the land the subject of this Easement and the successors, executors, administrators and assigns (as the case may be) of the Owner and all successors in title, lessees, trustees, occupiers and mortgagees of the registered proprietor’s interest in the Servient Tenement and any other person deriving an interest in the Servient Tenement;

“Pedestrian” means the definition of pedestrian contained in Section 89(7) of the Act;

“Public Thoroughfare” means the thoroughfare granted by this Easement including the Council Works;

“Public Thoroughfare Easement” means an easement provided for in Section 89(4) of the Act and includes this Easement;
