

# I'm a donor

## What does the donor conception information register mean for me?

The new *Assisted Reproductive Technology Act 2024* helps donor conceived people to understand their genetic history and identity.

## What is the register?

It will give donor conceived people (and others) access to details about you (the donor) and any donor conceived siblings. This will help donor conceived people understand their genetic background and identity.

The register will include information about donor conception procedures done before and after the new laws start, regardless of whether the donation was made anonymously.

All donor conceived people (16 or older) will be able to apply for information from the register.

## When will the register start?

The register won't be ready right away.

RBDM will be working with assisted reproductive technology providers to collect information and developing the register and service.

## My details in the register

The new laws don't allow details to be removed from the register. However, some details can only be released with your consent.

RBDM will contact you if your identifying details are given to a donor conceived person or their descendant.

Submit a form to RBDM if you **do not**:

- want to be contacted if your details are released, or
- consent to the details (that need your consent) to be released.

All forms will be available when the register starts.

## Donor conceived person's details

You can choose to apply for a donor conceived person's contact information and details from the register.

### Identifying details (only with donor conceived person's consent)

- name, full date of birth and place of birth
- name of the provider who carried out the donor conception procedure and the place it was done.

### Non-identifying details

- year of birth and sex

### Contact information (only with donor conceived person's consent)

- home address
- phone number or email address
- any other way the donor conceived person may be contacted.

## Who can ask for my information from the register?

### Donor conceived person (16 or older) can apply for:

#### *Identifying details*

- name and full date of birth.

#### *Non-identifying details*

- donor ID code
- year of birth and place of birth
- ethnicity and physical characteristics
- place where your gamete was taken
- relevant medical history
- profile information (hobbies or interests, family history, education, photos, correspondence, and psychological history).

#### *Contact information (only with your consent)*

### Parent of a donor conceived person can apply for:

#### *Identifying details (only with your consent)*

- name and full date of birth.

#### *Non-identifying details*

- donor ID code
- year of birth and place of birth
- ethnicity and physical characteristics
- place where your gamete was taken
- relevant medical history
- profile information (hobbies or interests, family history, education, photos, correspondence, and psychological history).

#### *Contact information (only with your consent)*

- home address

- any other way you may be contacted.

### A direct descendant of a donor conceived person can apply for:

#### *Identifying details*

- name and full date of birth.

#### *Non-identifying details*

- donor ID code
- year of birth and place of birth
- ethnicity and physical characteristics
- place where your gamete was taken
- relevant medical history
- profile information (hobbies or interests, family history, education, photos, correspondence, and psychological history).

#### *Contact information (only with your consent)*

- home address

### Person with parental responsibility for a donor conceived person (under 16) can apply for:

#### *Identifying details (only with your consent)*

- name and full date of birth.

#### *Non-identifying details*

- place where your gamete was taken
- relevant medical history
- profile information (hobbies or interests, family history, education, photos, correspondence, and psychological history).
