# What does the donor conception information register mean for my family?

The new Assisted Reproductive Technology Act 2024 will allow donor conceived people and their parent(s) to apply for information.

### What is the register?

It will give you access to details about the donor and any donor conceived siblings. This may help you understand the genetic history and health needs of your child.

The register will include information about donor conception procedures done before and after the new laws start.

All donor conceived people (16 or older) and their parent(s) will be able to apply for information from the register.

### When will the register start?

The register won't be ready right away.

The Registry of Births, Deaths and Marriages will be working with assisted reproductive technology providers to collect information and developing the register and service.

### Information parent(s) can apply for

Parent(s) can choose to apply for the donor's and/or any donor conceived siblings' contact information and details.

- name of the provider who carried out sibling's donor conception procedure and the place it happened.

### **Support**

Free specialised counselling services will be available to donor conceived people and their parent(s) who apply for information from the register.

Counselling will not be mandatory to apply for information in the register. However, it will be available to those who wish to use it.
