

**Changing Election Day Notice** 2024 TORRES STRAIT ISLAND REGIONAL COUNCIL ELECTIONS SATURDAY 23 MARCH 2024



On 29 January 2024, the Electoral Commission of Queensland (ECQ) published notice of the 2024 local government quadrennial elections to be held on Saturday, 16 March 2024.

However, as a result of the substantial deterioration of weather conditions preventing the provision of mobile polling services, the ECQ has determined it is necessary to change the date of the election.

In accordance with section 38(2) and (3) of the Local Government Electoral Act 2011, this notice advises of a new election (polling) day for the Torres Strait Island Regional Council to be held on Saturday, 23 March 2024.
