Acquisition of Land Act 1967

TAKING OF EASEMENT NOTICE BY THE MINISTER (No 01) 2024

Short title

1. This notice may be cited as the *Taking of Easement Notice by the Minister (No 01) 2024*.

Easement taken [ss.6 and 9(7) of the Act]

2. The easements described in Schedule 2 are taken by Brisbane City Council for Drainage (underground) purposes and vests in Brisbane City Council on and from 16 February 2024.

Rights and obligations

3. That the rights and obligations conferred and imposed by each easement include the matters set out in Schedule 1.

SCHEDULE 1

The Council holds an easement for the purposes, powers, rights and liberties set out below.

1. RIGHTS AND LIBERTIES

The full and free right and liberty at all times and from time to time to have, lay, construct and thereafter forever to use and maintain through the land described in the Schedule hereto (which land is hereinafter called "the said land") underground drains, pipes, conduits and channels for the passage or conveyance of rain water together with all associated drainage and stormwater run off and all manholes, manhole chambers, inlets, equipment and fittings in connection therewith or for the accommodation of any adjoining or neighbouring property or properties or otherwise in the execution of the Council's drainage powers and for the purpose aforesaid and for the purpose of obtaining free and uninterrupted access to the said drains, pipes, conduits and channels, manholes, manhole chambers, inlets, equipment and fittings (hereinafter called "the stormwater infrastructure") from within the said land and for the purpose of changing the size and the number of, operating, inspecting, patrolling, altering, removing, replacing, reconstructing and/or repairing the stormwater infrastructure, full free and uninterrupted right and liberty at all times by day and by night and from time to time to enter go, pass and repass along or through the said land or any part or parts thereof with or without surveyors, engineers, servants, agents, licensees, contractors, subcontractors, workmen

and others authorised by the Council together with all vehicles, equipment, machinery, tools and materials considered necessary by the Council and to dig into, sink shafts in, erect scaffolding and to open and break up the soil of the said land or any part or parts thereof and to bring and place in the said land or any part or parts thereof and remove such vehicles, equipment, machinery, tools and materials and to do such other incidental works and things in the said land as the Council and its successors shall in its and their discretion think fit. Despite the rights granted to Council, the Council may not access the stormwater infrastructure from the surface of the said land.
