# Queensland Sheep and Goat Electronic Identification Assistance Scheme Application Form

For saleyards, processors and Agricultural shows

The Queensland Government is committed to strengthening livestock traceability and the national commitment to implement mandatory sheep and goat individual electronic identification (eID) commences in Queensland on 1 January 2025.

The Queensland Sheep and Goat Electronic Identification Assistance Scheme provides financial assistance via a rebate to eligible saleyards, processors and Agricultural show sub-chambers to offset up to half the cost of purchasing eligible items, as part of the implementation of mandatory eID for sheep and managed goats in Queensland.

## Eligibility and assessment

Applications will be assessed according to the eligibility and conditions of the Scheme. Refer to the relevant Scheme guideline:

- Saleyard operators
- Processors
- Agricultural show sub-chambers

Written advice of a decision to approve or decline applications will be provided to applicants within 30 days of receipt of a completed application.

Assessment of incomplete applications will be paused and applicants advised to provide the outstanding information. When full application requirements are received the application will be placed in the assessment queue.
