1. This notice may be cited as the *Taking of Easement Notice (No 35) 2010*

**Easements taken [s.15 of the Act]**

2. The Easements described in Schedule 2 are taken by Rockhampton Regional Council for Drainage purposes and vest in Rockhampton Regional Council on and from 20 August 2010.

**Rights and obligations**

3. That the rights and obligations conferred and imposed by each Easement include the matters set out in Schedule 1.

**SCHEDULE 1****1. INTERPRETATION**

- 1.1 Herein -  
 “**Council**” means **ROCKHAMPTON REGIONAL COUNCIL** and includes the successors in title of the Council;  
 “**Easement Area**” means the area of land affected by the Easement in the lot burdened by the Easement without limitation as to height or depth;  
 “**facility**” includes work;  
 “**Land**” means each lot burdened by the Easement;  
 “**Owner**” means each registered owner of the interest in the lot burdened by the Easement and the successors in title of each registered owner;  
 “**structure**” means anything built or constructed, whether or not attached to land;  
 “**Works**” means the Council’s works at any time constructed, in the course of construction or to be constructed wholly beneath the surface of the Easement Area determined by the Council to be necessary for or in connection with the purpose for which this Easement is granted for or in respect of the Easement Area and, without limiting the generality, includes water mains, pipelines and other fittings and attachments including works for the protection and support of such things.
- 1.2 If any covenant or its application to the Owner, the Easement Area or circumstances shall be or become invalid or unenforceable, the remaining covenants of the Easement are not to be affected and each covenant is to be valid and enforceable to the fullest extent permitted by law.
- 1.3 References to statutes regulations local laws or subordinate local law extend to all statutes regulations local law or subordinate local law amending consolidating or replacing the same.
- 1.4 If the Owner comprises two or more legal entities, their covenants bind them jointly and each of them severally.
- 2. PURPOSE OF EASEMENT**
- 2.1 The Easement is for the Council to use the Easement Area for -
- 2.1.1 Drainage purposes;  
 and
- 2.1.2 Any service, facility or activity of whatever description which the Council has authority to undertake, in the exercise by the Council of the jurisdiction of local government, directly or indirectly referable to the purpose stated at Article 2.1.1.
- 3. WHAT THE COUNCIL IS ALLOWED TO DO**
- 3.1 To enable the Council to fully use the Easement Area for the purpose of the Easement, the Owner must allow the Council at any time without any interruption from the Owner or any occupier of the Land or any part of the Land to do all things upon, beneath or above the surface of the Easement Area at any time determined by the Council to be necessary for or in respect of the Works.
- 3.2 Without limiting the generality of the Article but by way of example, under Article 3.1 the Owner or any other occupier of any part of the Land must allow the Council -
- 3.2.1 to place the Works beneath the surface of the Easement Area;
- 3.2.2 to construct, operate, test, inspect, cleanse, maintain and repair the Works;
- 3.2.3 to alter, add to, augment, replace, extend or deviate the Works;
- 3.2.4 to dig up the surface and sub-surface of the Easement Area and remove any soil from the Easement Area (unless the Owner gives written notice that the Owner requires soil to remain stockpiled on the Easement Area);
- 3.2.5 to enter upon and remain upon the Easement Area;
- 3.2.6 to take down replace or modify any fencing on the Easement Area (subject nevertheless that the Council must give reasonable notice to the Owner in the case of stock-proof fencing to secure stock);
- and
- 3.2.7 to allow right of way, run and pass water, fluids, substances of any description, electric current, electric and gas transmissions, electronic signals and electronic transmissions through, from, to or about the Works or the Easement Area.
- 3.3 In doing anything allowed in respect of the Easement, the Council is entitled to do those things by its employees, agents and invitees and with or without the use of all necessary motor vehicles, machinery, equipment and implements.
- 3.4 All soil which the Council determines is to be dug up from the Easement Area for or in respect of the Works -
- 3.4.1 becomes the property of the Council;  
 and
- 3.4.2 is to be removed by the Council from the Easement Area at the cost and expense of the Council.
- 3.5 When an employee or agent or invitee of the Council enter onto and remain on the Easement Area under the Easement for or in respect of the Works and with or without the use of all necessary motor vehicles, machinery, equipment and implements -
- 3.5.1 the employee or agent or invitee of the Council are able to do so at any time;
- 3.5.2 the employee or agent or invitee of the Council may do so without any requirement for the Council or the employee or agent or invitee to obtain the further agreement of the Owner and any occupier of the Land;
- 3.5.3 consistent with the nature of the activity undertaken for or in respect of the Works, the Council is to reinstate, replace or restore the Easement Area or that part of the Easement Area to a condition determined by the Council to be as near as practicable (or better) than the condition of the Easement Area prior to the activity.
- 4. WHAT THE OWNER IS ALLOWED TO DO**
- 4.1 To enable the Council to fully use the Easement Area for the purpose of the Works, neither the Owner nor any occupier of the Land or part of the Land is to do or permit to be done anything on or in respect of the Works or the Easement Area which could obstruct or interfere with the Works or the proper and effective use of the Works by the Council.
- 4.2 Without limiting the generality of the Article but by way of example, under Article 4.1 the Owner or any other occupier of any part of the Land is not to -
- 4.2.1 build or erect any structure on, under or over the Easement Area unless specifically permitted, in writing, by Council;
- 4.2.2 plant trees or shrubs within the Easement Area or permit trees or shrubs planted on the Land outside the Easement Area to obstruct or interfere with the Works or the proper and effective use of the Works by the Council;
- 4.2.3 concrete all or any part of the surface of the Easement Area or stockpile any material thereon;
- 4.2.4 bitumen or pave all or any part of the Easement Area unless specifically permitted, in writing, by Council, which permission shall not be withheld in the case of bitumen or in the case of pavers, if the pavers are individually laid and removable for the purposes of access to the Works;
- 4.2.5 apart from external boundary fences across or along the Easement Area, which are not to be brick or masonry, fence the boundaries of the Easement Area in such a manner that Council’s access to the Works could be obstructed or interfered with;
- 4.3 If the Owner or any occupier of the Land or part of the Land does or permits to be done anything on or in respect of the Works or the Easement Area which could obstruct or interfere with the Works or the proper and effective use of the Works by the Council, the Owner is to do immediately all things at the cost and expense of the Owner as are necessary

to cease the obstruction or interference with the Works or the proper and effective use of the Works by the Council.

- 4.4 If, having failed to comply with Article 4.3, the Owner fails to comply with a notice from Council specifying:

- 4.4.1 what Council requires the Owner to do to remove the obstruction or stem the interference;  
4.4.2 the period within which Council requires the Owner to take that action (which period is to be determined by Council having regard to the nature and extent of the obstruction for interference)

Council may enter the Easement Area and remove the obstruction or stem the interference or otherwise do such acts or things as may be necessary to enforce the Council's rights hereunder.

- 4.5 All costs incurred by the Council (including the Council's usual administrative on costs and legal costs calculated on a solicitor and own client basis) in acting under Article 4.4 are a debt due and owing by the Owner to the Council payable by the Owner to the Council on demand.  
4.6 The Owner has no ownership in, nor claim to, any rights of ownership or interest in the Works which remain the property of the Council, at all times.

#### 5. WHO IS RESPONSIBLE FOR MAINTAINING THE EASEMENT AREA

- 5.1 In exercise of the Owner's right to use of the Easement Area (but in a manner not inconsistent with or in any way prejudicing the rights of the Council), the Owner is to keep and maintain the Easement Area in a condition appropriate for Council to enjoy its entitlement under the Easement.  
5.2 For clarity, Article 5.1 does not require the Owner to address subsidence, erosion or other adverse effect to the Easement Area resulting from the installation or continuing existence or operation of the Works, all of which shall remain the obligation and responsibility of the Council to remedy.  
5.3 Nothing herein is to operate or to take effect to relieve or to be deemed to relieve the Owner from the continuing need to comply at all times with the requirements of any Local Government Act, local law or subordinate local law that may have application to the Land or the Easement Area.

**Notice of adoption of amendments to the Brisbane City Plan 2000 pursuant to Schedule 1 of the *Integrated Planning Act 1997* by including a Local Plan entitled the "Lutwyche Road Corridor Neighbourhood Plan"**

At its meeting of 3 August 2010, Council adopted amendments to the Brisbane City Plan 2000 to include the Lutwyche Road Corridor Neighbourhood Plan together with consequential and supporting amendments.

**Purpose and General Effect of the draft amendments**

The purpose of the Lutwyche Road Corridor Neighbourhood Plan is to provide additional certainty about the development principles that should underpin future development for residents, landowners and developers in the area. The effect of the draft amendments will be to regulate land use in that area to allow higher density development in growth precincts around two major busway stations on Lutwyche Road, promote high quality urban design outcomes, improve the pedestrian and bicycle networks, further protect valued character and heritage housing and provide for improved open space and community facilities.

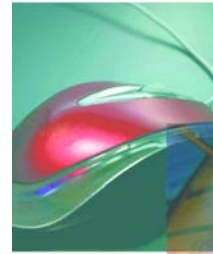

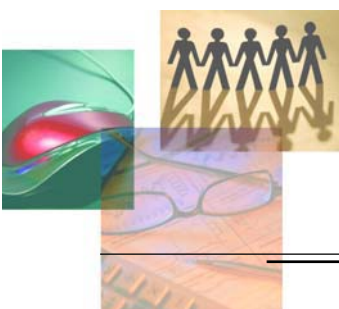

This means that agencies can 'dip' into the pool for suitable applicants as soon as they have a vacancy. You can submit or refresh your application at any time. If you are refreshing your application, make sure that you indicate this either on your email or, if sending by post, in a covering letter. In search results, continuous applicant pools can be identified by 'Ongoing' in the 'Closes' column of a search result.

Note: If a continuous applicant pool is closing, applicants will be notified two weeks prior to this date. Applications may be used for up to six months after the pool closes.

**MULTI-AGENCY POOLS**

Some Queensland Government agencies are on the lookout for people to fill similar jobs or occupations at the same time. Some of these jobs have a fixed closing date and others are ongoing (continuous applicant pools). With multi-agency pools, you only have to apply once to access job opportunities across participating agencies. Your application will then be able to be viewed and assessed by all the agencies in that pool - or, if you prefer, you can specify that you want to be considered only for particular agencies. Make sure you check the specific vacancy to find out how each pool works.

**HOW TO APPLY**

When you have found the job you would like to apply for.

1. You can phone for a copy of the information kit or you can download the documents from the Smart Jobs and Careers website at [www.jobs.qld.gov.au](http://www.jobs.qld.gov.au). The information kit will include:
  - the position or job description detailing: background of the department or work area; roles and responsibilities, and selection criteria
  - a job information package, outlining the procedure for preparing and sending in your application, and
  - an application cover sheet.
2. Do your homework - research the agency to understand the background to the job.
3. Prepare your application. This should include your:
  - completed cover sheet (available on jobs online or in the kit mailed to you)
  - covering letter
  - resumé / curriculum vitae
  - names and contact details of (2) referees, and
  - responses to the selection criteria if required.
4. Mail or email your application (Details of where and how are available in either the job description or the job information package).



Check with the job vacancy contact person if you are unsure about how or where to submit your application or how many copies to send. Make sure you send your application by the closing date. If you don't, it may not be accepted. Once your application is received, you will usually be sent a written acknowledgement.

## SCHEDULE

ATTENDANCE – RECORDING AND REPORTING REQUIREMENTS  
(INCLUDING PUBLIC HOLIDAYS)

## GENERAL CONDITIONS

**1. Records to be kept**

1.1 Subject to clause 1.2, attendance records are to be kept on all **public service employees**.

1.2 A chief executive is to maintain a system for recording, starting and ceasing times, meal breaks and absences from duty. This applies to all employees in his or her department except for those who have been, or who are of a class of office which has been specifically exempted by the chief executive.

1.3 A chief executive will ensure that arrangements are in place to monitor exempted employees' absences from duty where such absence is taken for a full working day or longer.

**2. Destruction of records**

2.1 The chief executive is to keep these records for 6 years.

**3. Reporting absences from duty**

3.1 Where a public service employee is prevented, for any reason, from attending work or performing duties he or she is to report the fact to his or her immediate supervisor or designated person as soon as is practical.

3.2 If a public service employee is absent without authority, his or her immediate supervisor is to report the fact to the chief executive.

**4. Public holidays**

4.1 A chief executive may require the whole or part of a department to remain open in the public interest for the whole or portion of a public holiday to be observed or a special holiday under the *Holidays Act 1983* and may require the attendance of any public service employee for this purpose.

## SCHEDULE

## BEREAVEMENT LEAVE

## GENERAL CONDITIONS

## 1. Entitlement

- 1.1 An employee (other than a casual employee) who is a public service officer or a temporary employee engaged under section 147(2)(a) of the *Public Service Act 2008* or a general employee engaged under section 148(2)(a) of the *Public Service Act 2008* (referred to as "employee" in this schedule) is to be granted paid bereavement leave on the death of a member of the employee's immediate family or household as provided in this schedule.
- 1.2 A "casual employee" (as defined in this schedule) is to be granted unpaid bereavement leave on the death of a member of the employee's immediate family or household as provided in this schedule.
- 1.3 If leave is required (e.g. for travel) in addition to the bereavement leave entitlements prescribed in this directive, public service officers and temporary employees engaged under s147(2)(a) of the *Public Service Act 2008* may apply for special leave on full pay for emergency situations or on compassionate grounds in accordance with the Ministerial Directive: *Special Leave*.

## 2. Definitions

## 2.1 "daily hours" means –

the number of ordinary daily working hours of an employee as specified in an industrial instrument (as defined);

in any other case – the number of hours determined from the relevant industrial instrument (as defined) as the average number of hours per working day of an employee during a pay period or other period reasonable in the circumstances.

## 2.2 "immediate family" includes –

- (a) the employee's spouse; or
- (b) a child, ex-nuptial child, step-child, adopted child, ex-foster child of the employee or employee's spouse; or
- (c) parent, grandparent, grandchild, sister or brother of the employee and of the employee's spouse (such as the employee's mother-in-law, father-in-law, grandparent-in-law, brother-in-law, sister-in-law, son-in-law, daughter-in-law).

The list of family members provided for in this definition is not exhaustive. Agencies have the discretion to grant bereavement leave to employees on the death of family members that are not expressly provided for in this definition. Cultural and personal reasons may be taken into consideration when an agency makes a decision.

2.3 "industrial instrument" for the purposes of this directive means an award, industrial agreement, certified agreement, contract, former determination of the Governor-in-Council, directive or determination made under section 149 of the *Industrial Relations Act 1999*.

## 2.4 "casual employee" includes both long term casual employees and short term casual employees.

## 2.5 "spouse" of an employee includes –

- (a) a former spouse; and
- (b) a defacto spouse, including a spouse of the same sex as the employee.

## 3. Satisfactory proof

- 3.1 The employee is to furnish evidence of the death or funeral arrangements that are satisfactory to the chief executive.

## 4. Conversion to hourly basis

- 4.1 Leave prescribed in this directive may be converted to an hourly basis for the purpose of granting and recording the leave.

## 5. Leave granted on an hourly basis

- 5.1 If an employee applies for leave on a basis other than an hourly basis, the leave may be granted on an hourly basis.

## 6. Leave entitlement in hours

- 6.1 If an employee's leave entitlement is expressed in working days, the leave entitlement may be read as if it were expressed in working hours using the following formula –

$$LE = WD \times DH$$

Where:

**LE** (leave entitlement) means the amount of leave entitlement expressed in working hours to which the employee is entitled.

**WD** (working days) means the number of working days set out in the directive.

**DH** (daily hours) means the employee's daily hours (as defined).

## 7. Leave based on the number of hours that the employee would have worked

- 7.1 Applications for bereavement leave are to be based on the number of hours that the employee was rostered to work on that day but did not work.

## Example 1

If an employee, working 7.25 hours a day, departs on bereavement leave after 3 hours, then 4.25 hours bereavement leave is to be applied for.

## Example 2

If an employee is rostered to work 7.6 hours and is absent on bereavement leave on that day, then 7.6 hours bereavement leave is to be applied for.

**JURY SERVICE****1. Leave**

1.1 An employee required to undertake service as a juror is to be granted leave on full salary for that purpose.

**2. Jury service fees**

2.1 Fees received by the employee for serving as a juror during the approved leave are to be forwarded to the chief executive for payment into departmental funds.

2.2 However, where on any day during approved leave the employee's salary is less than the fees payable for that day, the employee is entitled to retain the difference between the salary and the fee.

2.3 Fees received by the employee can be retained when serving as a juror for a period which is not covered by leave under this directive, e.g. when 'locked up' to consider a verdict over a public holiday or over a weekend or when the employee is on any other form of paid or unpaid leave.

**3. Travelling expenses**

3.1 An employee is entitled to retain any allowances received or expenses reimbursed for travel, accommodation or meals while attending court as a juror.

**4. Higher duties**

4.1 Employees performing higher duties shall continue to be paid their higher duties rate for jury service falling within their relieving period. The higher duties rate shall be paid irrespective of the length of the employee's relieving period.
