### **About this form**

Use this form to register your interest in joining the JPs in the Community program as a:

- volunteer Justice of the Peace (JP) or Commissioner for Declarations (Cdec) and/or
- participant in our mentoring program.

#### **Availability and Preferred Locations**

In this section of the Volunteer Registration Form, you can indicate your availability by selecting the days and times you are available to volunteer and/or be mentored. Ensure you include your full availability to ensure we can find you a suitable location.

When listing your preferred JPs in the Community locations, you can either list existing volunteer signing sites (visit <a href="https://www.gld.gov.au/findip">www.gld.gov.au/findip</a> for a full list of signing sites and their operating hours) or a suburb or area near you.

#### **Different levels of involvement**

When selecting how you would like to be involved, please **select one option** that best suits your wishes. This will vary depending on your current witnessing experience and the availability of ongoing volunteer shifts at your nominated signing site/s. **Note:** If you are an inexperienced or newly appointed JP or Cdec, we highly recommend you complete some form of mentoring before volunteering however, this is not mandatory.

#### **Additional Information**

Please let us know if there is anything that might affect your ability to volunteer on the Volunteer Registration Form. For example, if you do shift work, require wheelchair access, need your carer to accompany you, or have poor eyesight. Knowing this information at the time of registration, will assist our office greatly in finding the most suitable location for you to attend.

#### Other benefits of being a JPs in the Community Program volunteer

After successfully joining a roster at a JPs in the Community Program signing site, volunteers can request a complimentary polo shirt and/or ID card to help identify themselves as a volunteer in the JPs in the Community Program.

#### How do I request a complimentary polo shirt and/or ID card?

**Note:** The complimentary volunteer polo shirt and ID card is not available to JPs and Cdecs who only wish to be mentored at a signing site and do not intend on volunteering afterwards.
