Acquisition of Land Act 1967

TAKING OF EASEMENT NOTICE (No 02) 2024

Short title

1. This notice may be cited as the *Taking of Easement Notice (No 02) 2024*.

Easement taken [ss.6 and 9(7) of the Act]

2. The easement described in Schedule 2 is taken by Central SEQ Distributor-Retailer Authority for sewerage purposes and purposes incidental to sewerage and vest in Central SEQ Distributor-Retailer Authority on and from 2 August 2024.

Rights and obligations

3. That the rights and obligations conferred and imposed by each easement include the matters set out in Schedule 1.

SCHEDULE 1

1. DEFINITIONS AND REFERENCES

1.1 Definitions

In this easement:

Authorised Persons means employees, agents and contractors of, and other persons authorised, by Urban Utilities.

Easement Area means that part of the land over which this easement is taken.

Easement Term means a period of five years commencing on the date of publication of the Gazette Notice.

Form D2.2 means the Queensland State Revenue Office form required for stamping of the Surrender Document.

Grantor means the registered owner of the land subject to the Easement Area at the date the easement is taken for the purpose mentioned in the Gazette Notice.

Gazette Notice means the proposed notice, to be published in the Queensland Government Gazette under section 9, 15C or 15D of the *Acquisition of Land Act 1967* (Qld), declaring that the easement is taken for the purpose mentioned in the Gazette Notice.

Owner means any person who has an estate, interest, right, power or privilege in, over, or in relation to the land subject to the Easement Area and that person's administrators, assignees and successors.

Queensland Land Registry means the land registry responsible for administration of the registration of land titles in Queensland.

Urban Utilities means:

(a) the Central SEQ Distributor-Retailer Authority (trading as Urban Utilities), established under section 8 of the

South-East Queensland Water (Distribution and Retail Restructuring) Act 2009 and its assignees and successors; and

(b) if the context permits, Authorised Persons.

Sewerage Works means all pipes for carrying, treating or disposing of sewage and other wastewater, all ancillary plant, equipment, fittings and attachments (including pumps and pump stations) and works of any nature to protect or support any of them.

Surrender Document means the Queensland Land Registry Form 10.

1.2 References to things on Easement Area

In this easement, and unless the context indicates a contrary intention:

(a) a reference to a thing on, or the doing of anything on or in respect of, land in the Easement Area includes a reference to a thing, or the doing of the thing in, through, over, across or under the land; and

(b) a reference to the Easement Area includes the land's surface, sub-surface and strata above the surface.

2. TERM OF EASEMENT

2.1 The parties agree that the grant of this easement is for the Easement Term only.

3. PUBLIC UTILITY EASEMENT

3.1 This easement is a public utility easement for:

(a) the Sewerage Works;

(b) undertaking or engaging in any service, facility or activity that directly or indirectly refers to or is related to the Sewerage Works and which Urban Utilities has authority to undertake or engage in under a law; and

(c) the exercise by Urban Utilities of the other rights given to Urban Utilities by this easement.

4. URBAN UTILITIES' RIGHTS

4.1 Urban Utilities has the following rights under this easement:

(a) to transmit, or permit to be transmitted sewage and other wastewater in and through Sewerage Works on the Easement Area.

(b) to construct, place, lay, deepen, widen, inspect, clean, maintain, change, add to, remove, repair, replace, relay, renew, use and manage the Sewerage Works on the Easement Area at all times and from time to time;

(c) to run and pass electric current, electric transmissions, electronic signals, electronic transmissions and other substances through the Easement Area (including the Sewerage Works);

- (d) to do anything to remedy or prevent any infringement of its rights under this easement by an Owner or to enforce any obligation of an Owner under this easement, at the relevant Owner's cost; and
- (e) in order to exercise the rights in clauses 4.1(a) to (d):
- (i) enter the Easement Area, remain on it, and pass and repass on it, with or without vehicles, machinery, plant, equipment, tools and materials;
 - (ii) place on the Easement Area the machinery, plant, equipment, tools and materials required to exercise those rights and leave them there;
 - (iii) dig into, sink shafts in, excavate into and erect scaffolding on and open and break up the Easement Area;
 - (iv) remove and dispose of spoil created by the exercise of those rights;
 - (v) construct and maintain on the Easement Area those access tracks, fences, gates and ancillary works that Urban Utilities reasonably considers necessary;
 - (vi) clear vegetation from the Easement Area by any method and burn it off;
 - (vii) remove fences or gates on the Easement Area; and
 - (viii) do anything else on the Easement Area that the Urban Utilities considers reasonably necessary to exercise those rights.
- 5. OWNER'S OBLIGATIONS**
- 5.1 An Owner must allow the Sewerage Works to remain on the Easement Area.
- 5.2 An Owner must not, unless it has Urban Utilities prior written consent:
- (a) erect, install or lay any structure or other thing on the Easement Area;
 - (b) remove from or stockpile on the Easement Area soil, sand, gravel or any other substance or material;
 - (c) install concrete, bitumen or other pavement or driveways on the Easement Area or gardens or landscaping involving concrete, brick or other permanent materials or otherwise build over the Sewerage Works;
 - (d) alter the ground level, or alter or disturb the existing grades of the Easement Area or change its topography;
 - (e) inundate the Easement Area with water;
 - (f) plant any tree or other vegetation or crop on the Easement Area;
 - (g) light a fire on the Easement Area;
 - (h) construct any road or other earthwork on the Easement Area; or
 - (i) do or cause or permit anything (including granting rights to another person) in connection with the Easement Area that could obstruct or interfere with the Sewerage Works or their proper and effective use or the proper exercise of Urban Utilities' rights under this easement.
- 6. PROPERTY IN SEWERAGE WORKS**
- 6.1 The Sewerage Works are Urban Utilities' property and do not become an Owner's property.
- 7. EXERCISE OF URBAN UTILITIES' RIGHTS**
- 7.1 In exercising Urban Utilities rights under this easement, Urban Utilities must, at its own cost:
- (a) ensure all work is done in a proper and workmanlike manner; and
 - (b) comply with all relevant laws.
- 7.2 This easement does not affect any rights or powers Urban Utilities may have under a statute, including the *Water Supply (Safety and Reliability) Act 2008* and the *South-East Queensland Water (Distribution and Retail Restructuring) Act 2009*.
- 8. EXPIRY OF EASEMENT TERM**
- 8.1 As soon as reasonably practicable after the expiration of the Easement Term, Urban Utilities must:
- (a) prepare, complete, duly sign and stamp the Surrender Document;
 - (b) prepare and duly sign a Form D2.2; and
 - (c) lodge the Surrender Document at the Queensland Land Registry.
- 8.2 As soon as reasonably practicable after the expiration of the Easement Term, Urban Utilities must but subject to a requirement of a development condition imposed on Urban Utilities which if inconsistent or conflicts with the obligations herein shall take precedence to the extent of the inconsistency or conflict:
- (a) make good any damage caused to the Easement Area or Land by Urban Utilities; and
 - (b) restore the Easement Area to its condition at the start of the Easement Term, as far as it is practicable to do so.
- 8.3 However notwithstanding clause 8.2(a) and 8.2(b) Urban Utilities is only required to remove above ground infrastructure and improvements to at least a depth of 60 cm below the surface of the ground.
- 9. BURDEN**
- 9.1 The burden of this easement passes with the Easement Area.
- 9.2 Each promise made in this easement by the Grantor binds the Grantor's successors in title and is for the benefit of the Urban Utilities and its assignees.
- 9.3 Subject to clause 9.5, from the date the Grantor ceases to be the owner of the Easement Area, the Grantor is released from all obligations under this easement.
- 9.4 Despite clause 9.3, the Grantor is not released and remains liable for breaches of obligations that occurred before the date the Grantor ceases to be the owner of the Easement Area.
- 9.5 The Grantor, at its own cost, must, before it sells or otherwise disposes of the Easement Area, obtain from any buyer or donee of the Easement Area a covenant, in favour of Urban Utilities, by which the buyer or donee agrees to comply with the terms (whether positive or negative) of this easement.
- 9.6 Clause 9.3 does not apply unless clause 9.5 is complied with.

Interest has accrued on the overdue rates from the date they became overdue and continues to accrue at a rate of 12.35% per annum compounding daily.

The full notice which details each of the overdue rates on the land, the terms of Council's resolution to sell the land and the relevant provisions of the Regulation can be found on Council's website.
