From all of us at the Queensland Registry we thank you for your ongoing support and wish you and your family a happy and safe Christmas.


# Important information regarding witnessing Notice of Intended Marriage forms

According to the Commonwealth Attorney-General's Department, state appointed Commissioner for Declarations (CDEC) are not authorised to witness Notice of Intended Marriage (NOIM) forms. Examples of authorised witnesses who can witness a couple's NOIM include an authorised celebrant, a justice of the peace, a barrister or solicitor.

For a full list, please refer to the <u>Marriage Act 1961, Part IV, Division 2, section 42 (2)(c)</u>.

## Are you using our online marriage registration system?

For those of you who are wanting a more streamlined approach to managing your couple's marriage journey we invite you to sign up to our online marriage registration system where you can:

- · create and print official marriage documents
- · submit marriage records to us electronically
- · scan and upload signed official marriage documents
- transfer a notice of intended marriage to another online celebrant
- offer couples an easy way to get a standard marriage certificate or commemorative package from us
- · receive status updates
- · recall and amend a submitted registration, and
- receive fast notification about any issues we have registering a marriage.

It also helps you stay compliant with Attorney-General's Department form changes which are automatically updated in the system.

If you are still submitting registrations manually, we'd love to assist you transition to the online system.

## Your questions answered

One frequently asked question we receive regarding the online marriage registration system is 'when can we attach the signed forms?'

Once the ceremony has been solemnised and you have done a final review of the marriage registration details in the system, the signed Notice of Intended Marriage and Official Certificate of Marriage/Declaration of No Legal Impediment of Marriage can be attached so you can submit the registration.

## Reminder when submitting Official Certificate of Marriage forms

We receive a number of Notice of Intended Marriage (NOIM) forms without the corresponding Official Certificate of Marriage/Declaration of No Legal Impediment of Marriage (OCOM), meaning we are unable the register the marriage. Marriages can only be registered once we receive NOIMs and OCOMs that are fully completed with all pages provided.

## It's not just our process, it's the law

Under subsection 50(4) of the *Marriage Act 1961* authorised marriage celebrants, by law, must submit official marriage documents within 14 days of the marriage being solemnised.
