# Land Act 1994 OBJECTIONS TO PROPOSED ROAD CLOSURE NOTICE (No 32) 2015

#### **Short title**

1. This notice may be cited as the *Objections to Proposed Road Closure Notice (No 32) 2015.* 

# Application for road closure [s.100 of the Act]

**2.** An application has been made for the temporary closure of the road mentioned in the Schedule.

#### **Objections**

- 3.(1) An objection (in writing) to the proposed road closure mentioned in the Schedule may be lodged with the Executive Director, Department of Natural Resources and Mines, at the regional office for the region in which the road is situated.
- (2) Latest day for lodgement of objections is 24 September 2015.
- (3) Any objections received may be viewed by other parties interested in the proposed road closure under the provisions of the *Right to Information Act 2009*. If you lodge an objection, please include in your objection letter whether you would like to be consulted if this issue becomes the subject of an access request under the *Right to Information Act 2009*.

### Plans

- **4.** Inspection of the plan of the proposed road closure may be made at-
  - (a) the Department of Natural Resources and Mines Office at

Toowoomba; and

(b) the Local Government Offices of Western Downs Regional; for a particular plan in that district or that local government area. **SCHEDULE**
