Executive Summary

The Open Data Strategy for the **Department of State Development, Infrastructure and Planning (DSDIP)** sets out its plan for achieving the Government's commitment to the 'Open Data Revolution'.

The Department is responsible for driving the economic development of Queensland by diversifying and building resilience in regional and state economies, fast-tracking delivery of major resource and industrial developments and delivering major infrastructure and planning services to communities across Queensland while maintaining our quality of life and precious environment.

Our Structure

The department brings together the functions of the Coordinator-General, economic and regional development, infrastructure and planning into a strong central agency to grow the economy and champion the interests of business and industry for communities across Queensland.

The Department has eight business groups;

Office of the Coordinator-General—plans, coordinates and delivers the major resource and infrastructure projects that drives the state's economic growth.

Major Projects Office—removes impediments to investment and provides a 'one-stop shop' for the management, delivery and facilitation of high-priority commercial and infrastructure projects.

Planning Group—is reforming the state's planning system to foster economic growth, prioritise infrastructure, remove development blockages, manage environmental impacts and empower local governments to plan for their communities.

State Development Group—develops economic and infrastructure strategies, policies and plans and facilitates industry development and investment projects.

Economic Development Queensland (EDQ)—is the department's commercialised business unit for residential, urban and industrial development. Its primary focus is to facilitate economic development throughout Queensland. EDQ also undertakes a strategic planning function for Priority Development Areas.

Government Land and Asset Management Group—manages the state's property portfolio centrally and leads key property transactions like the Government Precinct Redevelopment, Mary Valley Property portfolio and the Gold Coast Cruise Ship Terminal on the Broadwater.

Regional Services—are the key economic development and planning services delivery group in the regions. They deliver these services on behalf of, or in partnership with, our business groups and other Queensland Government departments.

Strategy and Governance Group—provides corporate services and ensures focussed delivery of policy and procedures.



Open Data Strategic Overview

The Department's strategy will be consistent with the December 2012 Cabinet decision on Open Data which outlines the principles of data release, and the Open Data Senior Officers Working Group agreement that the strategy be based on a 4 year plan with annual reviews.

The Department will provide datasets in a suitable format that will help to foster innovation and efficiencies through the use of that data and promote openness and accountability in government.

The short term release strategy will focus on data where there are no privacy or confidentiality concerns, where data versioning and end-of-life information is established, and the structure of the data is suitable for release with no or minimal modification.

The Department's long term strategy is to release all data that does not have a valid privacy, commercial-in-confidence or security classification concern that would prevent its release. The strategy will be informed by the ongoing review of departmental operations that generate data and from public feedback on the use and quality of data released.

The Department collects and manages data related to planning services and schemes, infrastructure and resource project development, land and property management, economic development of the State and grants management, as well as information related to the Department's corporate services, performance and functions.

It is anticipated that large sections of the data requested and to be initially released by the Department will be geospatial in type and will require data governance arrangements specifically targeted to this type of data.

The Principles of Data Release

The principles of data release will be guided by the objective to release as much public data created and stored by the Queensland Government as possible and make it available free to anyone who wishes to use the data.

The key principles adopted by the Department for data release are:

- The Department will consider all data unless it is restricted for reasons of privacy, public safety, security classification, commercial confidentiality or compliance with the law and does not represent an undue operational risk.
- Data will be available for open use, by being freely available through the data.qld.gov.au website and provided in formats that will promote its reuse.
- The Department will endeavour to release data that is relevant and timely, and stored in a machine readable format suitable for public consumption.
- Data will be released under a Creative Commons with attribution licence, unless otherwise stated on datasets.



The department supports a data suitability checklist that will allow all departments to make clear decisions on which datasets will be released and what work is required to make them ready for publication.

Short Term Strategy

The short term release strategy will focus on data that is immediately suitable to release and is assessed as high worth to the community. The short term strategy will also focus on current rather than archive data but will make archive data available as part of the long term strategy or earlier if there is substantial demand for this data.

The short term release strategy will focus on developing procedures to:

- follow metadata standards
- provide versioning and end-of-life details
- apply clear licences (preferably open licences such as Creative Commons)
- include assessment and advice on data quality
- outline any limitations on data use (if any)

Long Term Strategy

The long term goal is to release all data where there is no valid concern that would prevent its release. Although the Department cannot foresee the usefulness of every dataset and how it could be used, the Department will initially prioritise datasets based on its assessment of community value until public and stakeholder feedback can inform the priority of data release.

The criteria for selection are based on datasets that have one or more of the following characteristics;

- allow new products or services to be developed by users of the data;
- capture the public interest;
- increase the openness and transparency of government and its processes;
- be used and analysed by researchers or non-government organisations;
- report on customer feedback and experience; and
- promote public debate.

When determining potential datasets, they will be assessed within the context of ensuring compliance with appropriate legislation and managing risk to the Department. The outcome of this assessment may result in the release of de-identified or aggregate data.

Future Program

The Department's release program will be based on the understanding that the release of certain data may subsequently generate multiple and complex requests.

It is anticipated that the Department will be required to update datasets more frequently, identify data elements in greater detail, or provide improvements to the quality of the data, which may have



additional resource implications for the Department. The aim of the Department will be to automate the release of these datasets where applicable based on user requests and feedback on the need for maintaining dataset currency.

Open Data reform affects all business groups within the Department and the inclusion of open data priorities into business planning and project planning processes will be considered and applied where appropriate. The Department will take measures to raise staff awareness of Open Data through a communications plan and provide training opportunities to staff responsible for data custodianship.

Opportunities to identify in-demand data and guide future releases will be developed from reviewing requests for information, stakeholder feedback and applications under Right to Information (RTI). Requests for material not currently released and containing complex requests will be risk managed through the Department's current RTI process.

Data Governance

The governing body for Open Data will be the Department's Information Steering Committee (ISC). This committee is the senior advisory body to the Director-General on the strategic application of information, communications and technology. The ISC will review this Strategy annually and will monitor the progress of the initiative through quarterly progress reports.

The Department has formed an Open Data Working Group to develop and mature the data release strategy. The working group will be responsible for ensuring that Open Data becomes a part of business-as-usual operations and that data is assessed for its appropriateness for release.

All data releases will be subject to an approval process for compliance to;

- short and long-term goals and objectives,
- overarching data identification process,
- release strategy procedures, and
- governance and compliance with standards including the protection of private and confidential data

Datasets that do not meet all of the above conditions will still be assessed for release as deidentified or aggregated data.

The Department recognises the importance of data currency and will establish versioning and endof-life details which will be provided with each dataset release.

Dataset Release Schedule
