COVID-19 update

Queensland is closing in on the next stage of eased travel and business restrictions which will come into effect from 17 December 2021 in line with [Queensland's COVID-19 Vaccine Plan to Unite Families](#).

[Public health and social measures from December 17](#) have been published along with [frequently asked questions](#). Additional materials including signage for businesses are available from the [Business Queensland website](#).

A free online training course from TAFE Queensland for businesses and their staff to help manage the entry of customers under the new measures is now available from the [TAFE Queensland website](#).

The [updated Check In Qld app](#) now allows people to link their vaccination certificates. This means the same fast check-in process will provide proof of vaccination status and support prompt contact tracing in the event of a positive case.

Business support programs

Payments of up to \$20,000 available for eligible employers

The revitalised Back to Work program is supporting Queensland employers who hire an eligible unemployed jobseeker from a targeted group who has experienced a minimum period of unemployment. Employer incentive payments of up to \$20,000 are available to eligible employers as well as a range of targeted support services to support the business and the employee.

Target groups include Aboriginal and Torres Strait Islander peoples, people with disability, long-term unemployed people and young people aged 15–24 years.

The application cap for employers has been reset to zero for employers who received funding under the previous Back to Work program (closed on 30 June 2021). From 1 July 2021, an eligible employer may make a further four applications under the revitalised Back to Work program. This is a great opportunity for employers who participated in the previous Back to Work program to re-engage with the new supports available under the revitalised Back to Work program.

Work in Paradise Tourism and Hospitality Jobs hub

Tourism and hospitality employers are encouraged to list available jobs on the new [Work in Paradise Tourism and Hospitality Jobs hub](#). Advertising vacant roles on the hub is free and employers can also find out about free or subsidised training available to help keep, and upgrade the skills of, current staff members.

The hub links to the Work in Paradise incentive which offers eligible jobseekers a \$1500 incentive to take up positions in regional areas, along with a \$250 Job Start Travel Bonus for people who have relocated more than 100 kilometres from their principal residence to take up a position. An advertising campaign is running now to promote this service and the jobs in the state's tourism and hospitality sectors. Business Boost and Business Support Grants paid

The Queensland Government has paid more than \$315 million in [COVID-19 Business Support Grants](#) to more than 34,000 businesses so far. Applications for employing businesses closed on 16 November and applications for non-employing sole traders closed on Tuesday 30 September, with submitted applications still being processed.

Earlier this month the Queensland Government's [Business Boost Grants Program](#) announced 210 small businesses would share \$2.6 million. The grants, which are worth up to \$15,000, support the businesses to access training and business coaching, strategic planning, marketing and other services such as upgrading websites.

Social enterprise update

On 18 November Minister Di Farmer [announced more than \\$1 million worth of support for the social enterprise sector](#). This includes:

- Over the next two years \$660,000 will support more social enterprises to supply to the Queensland Government.
- The Queensland Social Enterprise Council will receive \$385,000 for regional hub development activities and to raise the profile of social enterprises as suppliers to the private sector.
- \$100,000 sponsorship for the 2022 Social Enterprise World Forum which will be held in Brisbane with co-host White Box Enterprises.

In addition, the Queensland Government is continuing to deliver its Social Enterprise Jobs Fund programs, which supports the [Queensland Social Enterprise Strategy](#).

Farmers can apply for the [Queensland Agritourism Grants Program](#), run by the Queensland Farmers' Federation in partnership with the Queensland Government. Applications are **open until 10 January 2022** and the program offers a 50 per cent co-contribution capped at \$25,000 to establish or expand agritourism activities.

Nominations are open for the [2022 Queensland Greats Awards](#) until **Monday 31 January 2022**. The awards recognise extraordinary Queenslanders who have made a long-term contribution to, or whose achievements have significantly impacted the history and development of Queensland.
