## Next round of Business Boost grants on the way



Details of the next round of the popular <u>Business Boost grants</u> are now available. Businesses can **register their interest in applying from 9am on 12 August** through to 12 midnight on 19 August.

Previous recipients of a Business Boost grant have used the funds to introduce an online booking system, redevelop websites, develop a customised workplace health and safety system or train their staff.

To be eligible, small businesses need to employ less than 20 employees and have had a turnover between \$300,000 and \$600,000 in the last financial year.

Businesses will need to co-contribute at least 30 per cent of the total cost of their proposed project with grant funding paid to successful small businesses following completion of the project.

#### **Application process**

A new **two-stage application process** has been introduced to ensure all small businesses that are interested in this grant have an equal chance of being selected to apply. The first step is to register your interest to apply via the online form to provide basic information. Once registrations close, a number of businesses will be selected through a ballot process to complete a full application. All valid registrations of interest will have an equal chance of being selected.

## **Business Basics grants announced**

This week the Queensland Government also announced that more than 1000 Queensland small businesses will receive grants of \$5000 from round 3 of the <u>Business</u> <u>Basics program</u> which supports small business to get their 'business basics' on track by investing in areas such as website development, marketing plans or business coaching.

#### New programs to connect jobseekers and employers

Nine industry and community groups are the first recipients of the **Queensland Government's \$1.5 million Growing Workforce Participation Fund**, to trial new programs that will help jobseekers and employers to connect.

The Fund will support Queensland employers to address the labour and skills shortages they are facing, by improving the ways they engage with disadvantaged people who are looking for work. This may be through job-matching services, pre-employment pathways or other innovative resources and programs, which will be delivered across regional Queensland and in the Ipswich, Lockyer Valley, Logan, Moreton Bay, Scenic Rim and Somerset local government areas in the South East corner.

The groups awarded funding up to \$200,000 to deliver programs include Spinal Life Australia, Energy Skills Queensland, Australian Red Cross, Balonne Shire Council, Bowen Gumlu Growers' Association, Cairns Chamber of Commerce, Queensland Council of Social Service, Queensland Hotels Association and Toowoomba and Surat Basin Enterprise.

#### Minimum wage increase

The National Minimum Wage increased as of 1 July 2022 by \$40 per week, an increase of 5.2%. The increase follows the Fair Work Commission's decision for the Annual Wage Review 2021-2022 on 15 June.

- Award minimum wages have increased by 4.6%, which are subject to a minimum increase for adult award classifications of \$40 per week based on a 38-hour week for a full time employee.
- Other award wages, including junior, apprentice and supported wages that are based on adult minimum wages, will get a proportionate increase.
- Some awards will get a minimum wage increase from the first full pay period on or after 1 July 2022, while others will increase from the first full pay period on or after 1 October 2022.

The new rates are listed in the Fair Work Commission's <u>pay and conditions tool</u> and <u>pay</u> <u>guides</u>.

Micro-credentialing courses are delivered online through several bite-size videos. They provide operators with the flexibility to upskill and onboard new and current

employees with focused training in specific skills.

With more than 1,500 courses already completed, the micro-credentialing program is helping to fill critical skill gaps. The program has even inspired some existing employees to stay with employers by demonstrating a business' commitment to their learning and career progression.

# Have your say in the future of low emissions for Queensland agribusiness



We want Queensland's agribusiness sector to be a world-leader in low carbon production and supply chains, maximising carbon farming opportunities.

To help achieve this goal, the Queensland Government has developed a draft roadmap to help deliver greenhouse gas reductions and increase our carbon sinks – places that absorb more carbon than they release.

By 2032 the agriculture, fisheries and

forestry supply chains will be well on the way to lower emissions production, with the ultimate goal of a zero net emissions economy by 2050.

The roadmap's priority focus is food security and the economic stability of our food and fibre producing regions while actively transitioning to low emissions agriculture. The agriculture sector currently contributes 13 per cent of Queensland's total emissions, largely from livestock emissions.

All Queenslanders can provide feedback on the draft until 10 August 2022 on one or more of the five areas for action:

- Livestock emissions
- Cropping and horticulture emissions
- On-farm energy opportunities
- Carbon farming and land management
- Regions and supply chains.

## Single use plastics ban expansion

Queensland's ban on the supply of single-use plastic items started on 1 September 2021. The ban is part of Queensland's plan to tackle plastic pollution and follows strong support from the community, retailers and industry organisations.

Community, industry and business consultation has shown strong support to expand the ban of single-use plastics. As a result, the following single-use plastic items will be banned from 1 September 2023:

- cotton buds with plastic stems
- expanded polystyrene loose packaging
- plastic microbeads in rinseable personal care and cleaning products
- heavyweight plastic shopping bags
- mass release of lighter than air balloons.

#### Preparing your business

If you own or operate a business that uses banned items – such as a restaurant, café, takeaway food shop, party supplier, supermarket – you will <u>not</u> be able to provide these to your customers after the ban commences.

Take the time now to consider if you need to replace an item. To find out what your options are, follow the <u>three steps to prepare your business</u>.
