



#### Acquisition of Land Act 1967 TAKING OF EASEMENT BY THE MINISTER NOTICE (No 03) 2024

#### Short title

**1.** This notice may be cited as the *Taking of Easement by the Minister Notice (No 03) 2024.* 

#### Easement taken [ss.6 and 9(7) of the Act]

**2.** The easements described in Schedule 2 are taken by Brisbane City Council for right of way purposes and vest in Brisbane City Council on and from 5 April 2024.

#### **Rights and obligations**

**3.** That the rights and obligations conferred and imposed by each easement include the matters set out in Schedule 1.

#### **SCHEDULE 1**

The Council holds an easement for the purposes, powers, rights and liberties set out below.

#### EASEMENT TERMS

- 1. The full and free right and uninterrupted liberty at all times for Council and its Authorised Persons forever to go, pass and re-pass at all times and from time to time to use the land described in the Schedule hereto (which land is hereinafter referred to as the 'Easement') or any part thereof and in common with the Owner for the purposes of a shared use zone for vehicles, cyclists and pedestrians including to facilitate access requirements of cyclists, pedestrians and persons using personal mobility devices (all of which hereinafter referred to as 'Right of Way') at all times on the terms, conditions and restrictions contained in this Easement.
- 2. The Owner must:
  - (a) take all reasonable steps to minimise any interference with Council's and its Authorised Persons use of the Easement and to ensure that it is kept as an open pathway with no obstructions for the Right of Way; and
  - (b) take all reasonable steps to ensure the safety of Council and its Authorised Persons when accessing and using any part of the Easement with vehicles.
- 3. The Owner must not, without the prior written consent of Council;
  - (a) obstruct, place any structure on, interfere with or alter the Easement at any time;
  - (b) close or shut down (permanently or temporarily) the Easement or block access to and from the Easement;
  - (c) (i) undertake any works on the existing infrastructure within the Easement; and
  - (d) (ii) do anything to cause damage to the Easement.

- 4. The Council shall at all times cause the surface of the Easement to be kept and maintained in good, reasonable and trafficable condition, to the standard required by the Council, in its sole discretion, for the purposes of the Right of Way.
- 5. In addition to its other rights, Council is entitled to enter the Easement with or without vehicles or to undertake any works that the Council requires to construct, maintain, improve or repair the Easement and/or, inspect and/or monitor the Easement for the purposes of the Right of Way. The Council may close off the Easement during the period of those works as the Council requires.
- The Owner cannot be made civilly liable for an act done or omission made, honestly and without negligence, in relation to the exercise of the rights by Council and its Authorised Persons relation to the Right of Way.
- 7. That any notice to be given by the Council to the Owner hereunder shall be deemed to be sufficiently given if the same shall be made in writing for and on behalf of the Council by its Chief Executive Officer or the Chief Legal Counsel and be delivered personally to the Owner or sent by pre-paid post, addressed to the Owner at its Office for the time being in the City of Brisbane and any notice to be given by the Owner to the Council hereunder shall be deemed sufficiently given if the same shall be made in writing for and on behalf of the Owner by its General Manager, or other authorised person and be delivered personally to the Council or sent by pre-paid post addressed to the Chief Executive Officer or the Chief Legal Counsel, Brisbane City Council, Brisbane and any notice given or sent by post pursuant to this clause shall be deemed to have been received at the time when the letter containing such notice would in the ordinary course of post be delivered.
- 8. Where the context so admits or requires:
  - (a) the expression 'Authorised Persons' means employees, officers, agents, contractors, visitors, the general public, invitees, licensees of and other persons claiming by, through or under the Council.
  - (b) the expression 'Owner' shall include the respective transferees and assigns of the Owner and the registered proprietor or proprietors owner or owners (and their and each of their respective successors, executors, administrators and assigns as the case may be) and the occupier or occupiers for the time being of the land covered by the Easement;
  - (c) the expression 'Council' shall include the successors of the Council; and

(d) words importing the singular number include the plural number and vice versa and words importing any gender include the other genders and words importing only persons include corporations and/ or associations and/or bodies and vice versa in each respective case.
