TAKING OF EASEMENT NOTICE (No. 3) 2020

Short title

1. This notice may be cited as *Taking of Easement Notice (No. 3) 2020*.

Easements to be taken [s.6 and s.9 of the *Acquisition of Land Act 1967*]

2. The easements described in Schedule 2 are taken by the Cross River Rail Delivery Authority as a constructing authority for the purpose of delivering the Cross River Rail Project and vest in the Cross River Rail Delivery Authority on and from 13 August 2020.

Rights and Obligations

3. That the rights and obligations conferred and imposed by each easement include the matters set out in Schedule 1.

SCHEDULE 1

Rights and Obligation Under Easement

1. Definitions and interpretation

1.1. In this easement:

Associates means the Delivery Authority's officers, employees, agents, consultants, contractors, subcontractors, licensees, invitees and others authorised by the Delivery Authority.

Delivery Authority means the Cross River Rail Delivery Authority a body corporate under Section 9 of the *Cross River Rail Delivery Authority Act 2016*.

Easement means the easement taken by the Delivery Authority over a subsurface part of the Land.

Easement Area means the part of the Land over which the Easement is taken.

Equipment includes but is not limited to all necessary tools, implements, materials and machinery.

Land means the land over which the Easement is taken.

Law means all statutes, regulations, ordinances, subordinate legislation and by-laws as amended, consolidated or replaced.

Owner means the registered owner of the Land.

Rock Anchors means any rod, bolt or cable of metal or other composition howsoever set in place (including rock anchors, ground anchors, soil nails and rock pinning), including being cemented to the rock or other substratum surrounding such items with grout or cement or any other adhesive material whatsoever.

1.2. In this Easement, unless the context otherwise requires:

- (a) a reference to a person includes its successors and assigns;
- (b) a singular word includes the plural, and vice versa;
- (c) if a word is defined, another part of speech has a corresponding meaning;
- (d) unless stated otherwise, one provision does not limit the effect of another;
- (e) a reference to any law or to any provision of any law includes any modification or re-enactment of it, any legislative provision substituted for it and all regulations and statutory instruments issued under it;
- (f) a reference to conduct includes any omission, statement or undertaking, whether or not in writing;
- (g) the words "include", "including", "for example" or "such as" are not used as, nor are they to be interpreted as, words of limitation and, when introducing an example, do not limit the meaning of the words to which the example relates to that example or examples of a similar kind;

(h) headings do not affect the interpretation of this easement;

(i) if a provision of this easement is void, unenforceable or illegal, then that provision is severed and the remaining provisions has full force and effect.

2. Delivery Authority's rights

2.1. The Easement commences on the date the taking of easement notice is published in the Queensland Government Gazette.

2.2. The Delivery Authority and its Associates may enter on the Easement Area with or without Equipment and:

- (a) install, place, leave, inspect, repair, maintain or remove Rock Anchors;
- (b) do any ancillary works related to the work in clause 2.2(a); and
- (c) open the soil of the Easement Area and remove it to such an extent as may be necessary for the work in clause 2.2(a).

3. Delivery Authority's obligations to the owner

3.1. The Delivery Authority must, in exercising its rights under this Easement:

- (a) ensure that it conducts all work in a professional and skilful manner;
- (b) in accordance with all relevant Law.

4. What the owner must not do

4.1. The Owner must not interfere with or obstruct the Delivery Authority from exercising its rights under the Easement.

5. Surrender of Easement

5.1. If the Delivery Authority no longer requires the benefit of the Rock Anchors, the Delivery Authority must:

- (a) take all necessary steps, as promptly as reasonably practicable, for the surrender of this Easement; and
- (b) promptly notify the Owner when the surrender has been completed.

5.2. If required to do so by the Delivery Authority, the Owner must promptly sign and return any documents required to give effect to the surrender referred to in clause 5.1(a).

6. Rock Anchors to remain in situ

6.1. On or prior to the surrender of the Easement referred to in clause 5, the Delivery Authority must de-stress the Rock Anchors.

6.2. Following the surrender of the Easement in accordance with clause 5.1, the Owner may, at its cost, remove or otherwise damage or interfere with the Rock Anchors.

6.3. The Owner cannot require the Delivery Authority to remove the Rock Anchors from the Land.

7. Indemnity

7.1. The Delivery Authority enters and uses the Easement Area at its own risk.

7.2. The Delivery Authority indemnifies the Owner against any damage, expense, loss or liability (Claim) suffered or incurred by the Owner in respect of any act or omission of the Delivery Authority in the use of the Easement Area, except to the extent that any Claim is caused or contributed to (but only to the extent of that contribution) by the negligent act or omission of the Owner (including its employees, agents and contractors).
