Acquisition of Land Act 1967

TAKING OF EASEMENT NOTICE (No 01) 2024 Short title

1. This notice may be cited as the *Taking of Easement Notice* (No 01) 2024.

Easements taken [ss.6 and 9(6) of the Act]

2. The easements described in Schedule 2 are taken by Logan City Council for drainage purposes and vest in Logan City Council on and from 19 July 2024.

Rights and obligations

3. That the rights and obligations conferred and imposed by the easement include the matters set out in Schedule 1.

SCHEDULE 1

1 Grant

- 1.1. Subject to the terms of this document Council has the full, free and uninterrupted right and liberty at all times of the day and the night and from time to time at the Council's pleasure:
 - (a) to enter upon and traverse the Burdened Land for any purpose whatsoever connected with Council's Drainage Powers and whether or not such entry or traversement is for the benefit or detriment of the Burdened Land and whether or not it is for the benefit of the Owner's Land or any neighbouring or other lands:
 - (b) to carry out such works on the Burdened Land and do such things including, without limitation, digging, sinking shafts, erecting scaffolding, opening and breaking up the soil both surface and subsurface, placing and operating machinery and equipment, storing soil and gravel, laying Pipes, digging trenches and Drains and laying concrete on or within the Burdened Land as Council in its absolute discretion thinks necessary or desirable for any purpose whatsoever connected with Council's Drainage Powers and whether or not such works and things are:
 - (i) are for the benefit or detriment of the Burdened Land; and
 - (ii) are for the benefit of the Owner's Land or any neighbouring or other lands; and
 - (c) to permit the uninterrupted flow of Stormwater Drainage and whether flowing continuously, intermittently or occasionally, above or beneath the surface of the Burdened Land, and through or along the Drains or other means including, where applicable creeks, gullies or overland flow paths.

2. Limitation

- 2.1. The powers, rights and liberties contained in clause 1 shall in all respects be limited to:
 - (a) the surveying, testing and excavating for the Drains or Pipes, the laying and constructing of the Drains or Pipes and thereafter forever maintaining the Drains or Pipes over, under or through the Burdened Land; and
 - (b) the obtaining of free and uninterrupted access to any or any part of the Drains or Pipes from the surface of the Burdened Land for the purpose of laying, relaying, changing the size or number of, operating, inspecting, patrolling, altering, removing, replacing,

constructing, reconstructing and repairing the Drains or Pipes.

3. Council's Agents and equipment

- 3.1. The Council in exercising any of the powers, rights and liberties conferred by this document may do so by itself or by any one or more of Council's Agents.
- 3.2. The Council or the Council's Agents whether by themselves or in conjunction with others may exercise any one or more of the powers, rights and liberties conferred by this document on Council and if necessary with vehicles, machinery and equipment of any description whatsoever and if with such vehicles, machinery or equipment:
 - (a) for such vehicles, machinery or equipment to beladen or unladen; and
 - (b) for the continuous forward movements or threepointturning movements of the vehicle.

4. Owner not to obstruct easement

- 4.1. The Owner shall not make, cause, allow or permit:
 - (a) any obstruction, interruption, impeding, hampering or interference with, diversion, scouring, change or alteration in or to the flow of water or other matter, as the case may be, at any time;
 - (b) any obstruction, interruption, impeding, or hampering of or interference with the powers, rights and liberties granted and conferred on the Council or Council's Agents by this document;
 - (c) any ponding, storage, retention or deviation of water or other matter through or under the Burdened Land caused by or consequent upon:
 - (i) any use to which the Burdened Land is or might be put;
 - (ii) the erection, raising, making, placing of or suffering to stand or to remain any Structure, paving, vegetation (except grass which is kept properly mown at all times) or anything whatsoever upon the Burdened Land;
 - (iii) any alteration in level or gradient of the Burdened Land; or
 - (iv) any change to the surface of the Burdened Land or to the natural or artificial features of the Burdened Land which contain or assist in containing the flow of water or other matter on, under or through the Burdened Land; or
 - (d) any obstruction, erection, making, placing of or allowing to stand any Structure of any kind on or within the Burdened Land, unless permitted in writing by Council or the Director and only to the extent permitted and upon such terms and conditions as Council or the Director imposes or stipulates in the event of such permission being granted.
- 4.2. Without limiting clause 4.1, the Owner must ensure that any works which are constructed on or in the Burdened Land do not obstruct, interfere with, damage or cause any change or alteration to any works constructed by Council within the Burdened Land
- 4.3. Provided the Owner is not in breach of clause 4.1 and Council is not exercising its rights under clause 5, Council must either:
 - (a) reinstate all fences damaged by it in the exercise of any of its rights granted under this document; or
 - (b) in lieu of reinstating any such fence, install a gate the quality and materials of workmanship of which, except with the Owner's consent, must be not less than the quality and materials of workmanship of the existing fence. A gate so installed becomes the property of the Owner and thereafter must (subject to clause 4.4) be maintained by the Owner.

5. Council may remedy breach

5.1. If the Owner or any occupier of the Burdened Land or part of it breaches any part of clause 4, Council or Council's Agents may (without prejudice to any other remedy which Council might have) remedy such breach by:

- (a) demolishing, removing or otherwise disposing of any Structure, paving, vegetation or thing whatsoever;
- (b) performing any works or doing anything necessary for restoring, repairing or reinstating the Drains or Pipes and the Burdened Land (including regrassing it) and reforming the natural or artificial features containing or assisting in containing the flow of water and other matter, as the case may be, above under or through the Burdened Land to their former state and condition;
- (c) altering, grading, paving, preparing, grassing and fertilising or mowing the surface of the Burdened Land or placing, installing, establishing or constructing and keeping any earthworks and any other works whatsoever (whether of the class just mentioned or not) on or in the Burdened Land.
- 5.2. Should Council or Council's Agents exercise any of the rights, powers and remedies contained in clause 5.1, then the cost of exercising those rights, powers and remedies and the doing and performing of any works, making alterations, grading, paving, preparing, grassing, fertilising, mowing, demolishing, removing or disposing of any Structure, paving, vegetation or anything whatsoever shall be at the cost of the Owner of the Burdened Land.
- 5.3. The Owner confers on the Council and Council's Agents all of the powers, rights and liberties mentioned in clauses 1 and 3 for the purpose of carrying out the rights, powers and remedies conferred on the Council by clause 5.1.

6. Indemnity

(a) The Owner indemnifies Council and agrees at all times hereafter to keep it indemnified in respect of any claims, demands or actions which are made or brought against Council as a result of the installation, maintenance or use of the Drains or Pipes if such loss, damage, claim or action is in any way attributable to the negligence or deliberate act of the Owner, its servants, agents, employees, invitees or licensees or the occupiers of the Owner's Land.

7. Owner to maintain Burdened Land

- 7.1. Subject to clause 7:
 - (a) the Owner shall at all times maintain and keep the Burdened Land and the Owner's improvements on and in the Burdened Land (but, subject to clauses 7.1
 (b) and 7.1(c), excluding the Drain or Pipes) in good order and repair and in a clean and tidy condition;
 - (b) if there are no such improvements or if the Drain is an open Drain (with or without embankments) the Owner undertakes to grass the Burdened Land and to keep it properly grassed and mown or otherwise appropriately vegetated to the reasonable satisfaction of Council; and.
 - (c) if Council constructs works or provides vegetation to minimise scouring or erosion within the Burdened Land then Council will maintain such works other than vegetation. The Owner shall maintain all vegetation in accordance with clause 7.1(b).

8. General Provisions

- 8.1. Notwithstanding any rule of law or equity all Drains, pipelines, Pipes, drips, valves, fittings, meters, connections and all other equipment and appurtenances brought onto, laid or installed upon or buried in or under the Burdened Land by Council at all times remain the property of Council notwithstanding that they are or might be annexed to the Burdened Land.
- 8.2. At any time and from time to time Council may remove all Drains, pipelines, Pipes, drips, valves, fittings, meters, connections and all other equipment and appurtenances brought onto, laid or installed upon or buried in or under the Burdened Land in whole or in part.
- 8.3. The Council, performing and observing the covenants and conditions to be observed and performed by it under this document, may peaceably hold and enjoy the rights, liberties, privileges and easement granted by this

- document without hindrance, molestation or interruption by the Owner or any person, firm or corporation.
- 8.4. If approval is given under the Planning Scheme for the Owner to grant another easement to a third party over the Burdened Land (Third Party Easement):
 - (a) any infrastructure which is installed pursuant to the Third Party Easement must be approved in writing by Council or the Director upon such terms and conditions as Council or the Director imposes or stipulates in the event of such permission being granted;
 - (b) the rights and interests of the grantee under the Third Party Easement must not interfere with Council's rights and interests under this document; and
 - (c) in the event of any inconsistency between this document and the Third Party Easement, this document prevails.

9. Definitions and interpretation

9.1. Definitions

In this document unless the context or subject matter otherwise indicates or requires:

Burdened Land means the part of the Owner's Land subject to the Easement and includes the airspace above that land.

Council means Logan City Council and its successors, transferees and assigns.

Council's Agents includes the employees, agents, licensees, contractors, sub-contractors and professional consultants of Council.

Council's Drainage Powers includes the drainage powers given to Council by its Local Laws, the Local Government Act 2009 (Old), the Planning Act, the Water Supply (Safety and Reliability) Act 2008 (Old), the South-East Queensland Water (Distribution and Retail Restructuring) Act 2009 (Old) and the powers, rights and liberties conferred on Council by this document and any other relevant statute.

Director means the Director for the time being responsible for the delivery of Council's road and water infrastructure requirements.

Drain includes a drain (open or closed), Pipe, conduit or channel (including, if applicable any overland flow path) above or below ground level, with or without embankments, for the passage or conveyance of water or other matter and any manhole, manhole chamber, inlet, any equipment (whether mechanical or otherwise including water reservoirs) and any fittings or works in support of or in connection with it. Easement means the easement over the Owner's Land in favour of Council, described on survey plan. Owner means the registered owner of the Owner's Land and includes the respective transferees and assignees of the Owner and the registered owner or owners (and their and each of their respective successors, executors, administrators and assigns as the case may be) and the occupier or occupiers for the time being of the Burdened Land.

Owner's Land means the Lot burdened by the easement.

Pipe includes a pipe, Drain, conduit or channel above or below ground level for the passage or conveyance of water or other matter and any manholes, manhole chamber, surface box, inlet, valve, main, equipment (whether mechanical or otherwise) and fittings or works in support of or in connection with it.

Planning Scheme has the meaning given to that term in the Planning Act 2016 (Old) or its successor. Stormwater Drainage means drainage of any kinds and, without limitation, includes rainwater, stormwater, liquid wastes and stormwater runoff and whether flowing individually or in concentration.

Structure includes buildings, fences and walls.

9.2. Interpretation

- (a) In this document unless a contrary intention appears:
 - (i) a clause is to a clause in this document;
 - (ii) the singular includes the plural and vice versa;
 - (iii) any gender includes all other genders;
 - (iv) a person includes a firm, a corporation, an association and a body, whether incorporated or not and a government or statutory body or authority;
 - a statute includes statutory instruments under it, and consolidations, amendments, reenactments or replacements of any of them;
 - (vi) writing includes any mode of representing or reproducing words in tangible and permanently visible form and includes facsimile transmission; and
 - (vii) this or any other document includes the document as varied or replaced and is not affected by any change in the identity of the parties.
- (b) The clause headings appearing in this document are inserted for convenience of reference and do not affect the construction of this document.
- (c) If any words are italicised or otherwise printed differently, this has been done for convenience only and does not affect the construction of this document.
- (d) Whenever more persons than one constitutes the Owner all the covenants, agreements, conditions, restrictions and provisos on the part of the Owner contained or implied in this document bind those persons jointly and each of them severally.
- (e) This document is in all respects to be interpreted in accordance with the laws of the State of Queensland and the parties irrevocably and unconditionally submit to the non-exclusive jurisdiction of the courts of Queensland, and any courts having jurisdiction to hear appeals from them, and waive any right to object to proceedings being brought in those courts.
- (f) Nothing contained in this document affects, prejudices or derogates from the requirements of any statute or from the rights, powers and authorities of the Council under the provisions of any statute or under any declared policy of Council including the rights, powers and authorities of Council as the local government.
- (g) An inclusive definition, or an example or particularisation of a provision, does not limit but may extend that definition or provision.
- (h) Where a word or expression is defined, other parts of speech and grammatical forms of that word or expression have a corresponding definition.
- (i) If at any time a provision of this document is or becomes illegal, invalid or unenforceable in any respect, during that time the illegality, invalidity or unenforceability will not affect or impair the legality, validity or enforceability of any other provision of this document.

Acquisition of Land Act 1967

TAKING OF EASEMENT NOTICE EAS 2993 (1) (2024) Short title

1. This notice may be cited as the Taking of Easement Notice EAS 2993 (1) (2024)

Easement taken [ss.6 and 15 (d) of the Act]

2. The easement described in Schedule 2 is taken by Northern SEQ Distributor-Retailer Authority (trading as Unitywater) for works for the reticulation of water supply and vests in Northern SEQ Distributor-Retailer Authority (trading as Unitywater) on and from 19 July 2024.

Rights and obligations

3. That the rights and obligations conferred and imposed by the Easement include the matters set out in Schedule 1.

SCHEDULE 1

1. DEFINITIONS AND INTERPRETATION

1.1 Definitions

In this Easement unless the context or subject matter require otherwise:

- Easement Land means that part of the land over which this easement is taken;
- (b) Matter means buildings, structures or other materials or things erected, placed, found or installed upon the Easement Land and includes trees and plants within the Easement Land;
- (c) Owner means any person who has an estate, interest, right, power or privilege in, over, or in relation to the land subject to the Easement Land and that person's administrators, assignees and successors; and

(d) Relevant Works means:

- (i) where the purpose of this Easement is "Sewerage":
 - sewer(s) and/or pipeline(s) for the purpose of conveying sewerage and all kinds of waste through, across or under the Easement Land together with manholes, stopcocks and all other usual or necessary fittings and attachments (including pumps and/or pump stations where required) as well as works for the protection and/or support of such things; and
- (ii) where the purpose of this Easement is "Water Supply":
 - water reticulation mains and/or pipelines for the purpose of conveying water supplied by Unitywater through, across or under the Easement Land together with manholes, stopcocks, meters, pressure control devices, pumps and/or pump stations, water reservoirs, and all other usual or necessary fittings and attachments as well as works for the protection and/or support of all such things; and

(e) Unitywater means:

- (i) The Northern SEQ Distributor-Retailer Authority (trading as Unitywater) established under section 8 of the South-East Queensland Water (Distribution and Retail Restructuring) Act 2009 and its assignees and successors; and
- (ii) If the context permits, Authorised Persons.

1.2 Interpretation

In this Easement:

(a) a reference to a statute includes Orders in Council, Proclamations, Regulations, Rules, Local Laws and Ordinances made under the statute and any

- statute amending, consolidation or replacing the statute:
- (b) headings have been included for ease of reference and guidance and this Easement is to be construed without reference to them;
- (c) the singular number includes the plural and vice versa;
- (d) words importing a masculine gender includes all other genders; and
- (e) words importing persons include companies and corporations and vice versa;
- (f) if a covenant contained in this Easement is or becomes invalid or unenforceable, the remaining covenants contained in this Easement remain in full force and effect; and
- (g) if a party to this Easement comprises two or more legal entities, the covenants contained in this Easement bind each of them jointly and severally.

2. RIGHTS OF UNITYWATER

2.1 Access

Where the purpose of this Easement includes Access, the following will apply:

The Owner grants to Unitywater the full and free right and liberty at all times, after the date of this Easement, to enter upon and remain, pass and repass on and over the Easement Land at will and as often as the occasion requires, with employees, agents and contractors and other persons authorised by Unitywater and with or without vehicles, plant and equipment of any description whatsoever.

2.2 Sewerage or Water Supply or Both

Where the purpose of this Easement includes Sewerage or Water Supply or both the following will apply

The Owner grants Unitywater the full and free right and liberty at all times, after the date of this Easement, to enter upon the Easement Land for the purposes of constructing and thereafter forever using and maintaining the Relevant Works as it shall from time to time think fit and in so doing, Unitywater by its employees, agents and other persons authorised by Unitywater has the right to:

- (a) construct, install, extend, deepen, widen, cleanse, add to, remove, inspect, maintain and repair the Relevant Works and when and where thought fit by Unitywater to remove and replace the Relevant Works with new Relevant Works (whether of a similar nature to those replaced or not);
- (b) to change the size and number of any pipes which form part of the Relevant Works;
- (c) dig into, sink shafts in, and erect scaffolding upon the Easement Land and to open and break up the soil of the Easement Land or any part of the Easement Land including its sub-surface;
- remove and dispose of spoil created as a consequence of exercising its rights hereunder;
- (e) clear and keep clear the Easement Land by any means or method and to cut and remove timber, trees and undergrowth from the Easement Land and to burn off such timber, trees and undergrowth;
- (f) construct and maintain on the Easement Land such access tracks, gates and appurtenant works as it considers necessary;
- (g) enter upon and remain, pass and repass on and over the Easement Land for all or any of the purposes aforesaid with or without vehicles, plant and equipment of any description whatsoever;
- (h) enter and exit to and from the Easement Land over such part or parts of the Owner's land adjoining or adjacent to the Easement Land as is reasonably required by Unitywater and Unitywater shall consider most convenient or necessary for the purpose of passing between the Easement Land and the most convenient

point of entry to or exit from the Owner's land (whether adjoining a constructed road or not);

- do such other works and things through, across, in or under the Easement Land as are incidental to the proper exercise of the rights granted to Unitywater under this Easement; and
- (j) use such part or parts of the Owner's land immediately adjacent to or adjoining either side of the Easement Land as may be reasonably required by Unitywater for the proper exercise of the rights granted to Unitywater under this Easement.

3. PROPERTY IN RELEVANT WORKS

The Relevant Works are and remain the property of Unitywater notwithstanding any actual or apparent affixing to the Easement Land. Unitywater shall be solely responsible, for the operation and maintenance of all Relevant Works.

4. FENCING

4.1 Removal

For the purpose of gaining access to the Easement Land, Unitywater may demolish or break open any fencing on or adjacent to the Easement Land. However, if livestock are contained within the fenced area, Unitywater must give reasonable notice to the Owner to enable the Owner to secure the livestock.

4.2 Reinstatement

Unitywater must either:

- (a) reinstate all fences (other than a fence erected in contravention of Clause 5) damaged by Unitywater in the exercise and performance of any of the rights and liberties granted to Unitywater under this Easement; or
- (b) if the fences are not reinstated, install a gate using materials and employing workmanship which is not less than the quality of the materials and workmanship in the existing fence. The gate installed pursuant to this subclause becomes the property of the owner of the fence in which the gate is installed and after installation shall be maintained by the owner.

5. NO STRUCTURES ON THE EASEMENT LAND

The Owner must not at any time without the express written permission of Unitywater (which must not be unreasonably withheld):

- (a) erect any buildings or structures (other than fences) upon the Easement Land or any part of it;
- (b) permit the Easement Land or any part of it to be used in such a way as to obstruct or interfere with the Relevant Works and/or the proper and effective use of the Relevant Works by Unitywater;
- (c) install concrete, bitumen or other pavement or driveways (except residential driveways) on the Easement Land or gardens or landscaping involving concrete, brick or other permanent materials; or
- (d) remove or stockpile or permit the removal or stockpiling of any soil, sand, gravel or other substance or material on the Easement Land or construct any roads, dam walls or other earthworks on the Easement Land which would in any way obstruct or interfere with the Relevant Works and/or the proper and effective use of the Relevant Works by Unitywater.

6. DAMAGE TO STRUCTURES

- (a) Unitywater acting reasonably at all times and complying with all relevant laws, will determine how and in what manner the rights granted to Unitywater under this Easement are exercised.
- (b) Unitywater must not wilfully damage or destroy any Matter to any extent greater than is reasonably

necessary in order to exercise its rights under this Easement but:

- Unitywater is not otherwise responsible for any damage to or destruction of any Matter in the course of the exercise by Unitywater of its rights under this Easement; and
- (ii) subject to Clause 4, Unitywater is not under any obligation to reinstate or repair any Matter damaged or destroyed in consequence of the exercise by Unitywater of its rights under this Easement and its only obligation where such Matter has been so damaged or destroyed is to leave the Easement Land in as clean and tidy state as practicable having regard to the nature of the Matter which has been damaged or destroyed and the work which it has done; and
- (iii) Unitywater is not in any event responsible for any inconvenience or disturbance to the Owner or occupiers of the Easement Land arising out of the exercise by Unitywater of its rights under this Easement.

7. REMOVAL OF UNAUTHORISED STRUCTURES

If a Matter is erected, placed, found or installed upon the Easement Land in contravention of Clause 5, Unitywater may, in addition to any other remedies and after having first given the Owner reasonable notice of its intention to invoke this clause, enter upon the Easement Land and remove or demolish the Matter and, if it does so:

- it may dispose of the Matter or any resultant demolition materials in such manner as it sees fit without being liable to account to the Owner therefore (except as provided in subclause (b) of this clause); and
- (b) it may recover, in any Court of competent jurisdiction, costs actually incurred by it in taking that action (including internal wage and salary costs) less any moneys actually received by it as a result of disposing of the Matter or any resultant demolition materials.

8. PROTECTION OF RELEVANT WORKS

The Owner will not do any act or make any omission which will jeopardise or prejudicially affect the safety or reliable working of any Relevant Works.

9. RATES AND CHARGES

The Owner is responsible for all local authority rates and assessments and lawful charges in relation to the Easement Land.

10. FURTHER ASSURANCES

The benefit and burden of this Easement shall pass with and bind the Easement Land so as to enure to and bind all persons deriving title thereto from and under the Owner and Unitywater respectively and the Owner, whenever required by Unitywater or the person or persons for the time being entitled to the benefit of this Easement, must do all such things and give all such assurances as are reasonably required for the proper and effective carrying into effect of the rights conferred under this Easement but not so as to render the Owner liable to be called upon to contribute towards the maintenance and upkeep of the Relevant Works.

11. SPECIAL COVENANTS FOR STATE RESERVE LAND

- (a) The following clauses are in addition to or replace where noted those set out above and will form part of the covenants of this Easement when any land is designated as a "Reserve" in accordance with the Land Act 1994 (as amended from time to time).
- (b) In this clause:

"Minister" means the Minister administering the Land Act 1994 (as amended from time to time); and "Trustee" means the relevant Trustee of the State Reserved Land.

(c) Reinstatement of fencing

Clause 4.2 of this Easement is deleted and replaced with the following:

Unitywater must either:

- (a) Reinstate all fences damaged by it in the exercise of any of its rights granted herein;
- (b) In lieu of reinstating any such fence, install a gate the quality and materials of workmanship of which must be not less than the quality and materials of workmanship of the existing fence.

(d) Removal of Unauthorised structures etc

Clause 7 of this Easement is omitted and replaced with the following:

If anything is erected, placed, found or installed upon the Easement Land in contravention of Clause 5, Unitywater may, in addition to any other remedies, and having given the Owner reasonable notice of its intention to invoke this clause, enter Easement Land and remove or demolish the Matter. If it does so it may dispose of the Matter or any resultant demolition materials in such manner as it sees fit without being liable.

(e) Removal of Trees

Unitywater must not cut or remove timber or tress from the Easement Land without first giving reasonable notice to the Owner and obtaining all necessary permits. Such notice will not be required under this clause in the event that there is an actual or potential danger to persons or property or there is any interference or jeopardy to the supply of the Relevant Works.

(f) Removal of Assets upon termination of easement Under the Land Act 1994, an easement over a reserve ends when the dedication of reserve is revoked unless a written approval is provided by the Minister that the easement may continue over unallocated State Land when the dedication of reserve is revoked.

Upon termination of the Easement, Unitywater

- (i.) must ensure that the Easement Land is left in a safe and stable condition to the satisfaction of the Minister; and
- (ii.) will unless directed by the Minister otherwise, at its own cost and expense, remove all of the Relevant Works from the Easement Land; and
- (iii.) will remove, at its own cost and expense, all of the Relevant Works from the Easement Land that may cause contamination or environmental harm to the Easement Land as defined by the *Environmental Protection Act* 1994 or similar legislation.

(g) Indemnity and Risk

The following clauses will apply for the duration of the Easement and will continue to apply during the periods of rehabilitation and any removal of the Relevant Works under clause 11 (f):

(i.) Indemnity

 Unitywater indemnifies and agrees to keep indemnified the Minister, the State of Queensland, Trustee and

- Owner (the "indemnified parties") against all actions, suits, proceedings, claims, demands, costs, losses, damages and expenses ("Claims") arising out of or in any way connected to or resulting from the granting of this Easement to Unitywater or which is connected to or resulting from Unitywater's use and occupation of the Easement Land (all of which are referred to as "the indemnified acts or omissions") save to the extent that the claim arises as a result of any negligent act or omission of the indemnified parties, however, any negligent act or omission or one of the indemnified parties does not negate the indemnity to any other indemnified parties.
- b. Unitywater hereby releases and discharges the indemnified parties from any Claim relating to the indemnified acts or omissions which may be made against the indemnified parties, save to the extent that the Claim arises as a result of any negligent act or omission of the indemnified parties, however, any negligent act or omission of one of the indemnified parties does not negate the release and discharge in favour of any of the other indemnified parties.

(ii.) Public Risk

Unitywater must effect a public liability insurance policy with an insurer authorised under the Insurance Act 1973 (Commonwealth) or, in any other case, to the satisfaction of the Minister naming Unitywater as the insured covering legal liability for any loss of, or damage to any property and for the injury (including death) to any person arising out of anything done or omitted on or about the easement land or any improvements thereon and claims, against all demands, proceedings, costs, charges and expenses whatsoever in respect thereof subject to the terms and conditions of the insurance policy.

b. Such policy must:

- (a) be for an amount not less than \$20,000,000.00 (Twenty Million dollars) in respect of all claims arising out of a single event or such higher amounts as the Minister may reasonably require; and
- (b) be effected on a "claims occurring" basis so that any claim made by Unitywater under the policy after expiration of the period of policy cover but relating to an event occurring during the currency of the policy will be covered by the policy subject to the claim meeting the policy's other terms and conditions; and
- (c) be maintained at all times during the currency of the Easement,

and upon receipt of any Notice of Cancellation, Unitywater must immediately effect another public liability insurance policy in accordance with the provisions of this Clause 11(g) (ii.).

- c. Unitywater must also provide a certificate of currency within 14 days of a request by the Owner who may only make such request once a year.
- d. Unitywater must, as soon as practicable, inform the Minister and Owner in writing, of the occurrence of any event that Unitywater considers is likely to give rise to a claim under the policy of insurance effected and must ensure that the Minter and Owner are kept fully informed of subsequent actions and developments concerning the claim.

(h) Power of Attorney

Whilst the Easement Land remains unallocated State Land or is dedicated as a Reserve pursuant to the Land Act 1994 as amended from time to time or is registered solely in the name of the State of Queensland, Unitywater irrevocably appoints in so far as it is legally able to the State of Queensland the true and lawful attorney of Unitywater enabling the attorney to do all such things as the attorney may consider necessary or desirable to effect a surrender of this easement upon the default by Unitywater of any condition, covenant or clause of this easement provided however that the State of Queensland may only exercise its right to surrender the easement under this clause if:

- (i.) Unitywater has breached a condition, covenant or clause of this easement; and
- (ii.) the State of Queensland has given written notice to the breach of Unitywater; and
- (iii.) the State of Queensland has allowed Unitywater 90 days from the date of receipt of the notice to remedy the breach; and
- (iv.) Unitywater has not remedied the breach by the expiration of that 90 days.

1. Introduction

This Public Health Services Table of Costs commences 1 July 2024.

It sets out the fees applicable for treating workers covered under the workers' compensation statutory scheme as public patients in Queensland public hospitals and is published in the Industrial Gazette.

This table of costs only applies to the services provided to:

- a worker who is discharged from a public hospital (an inpatient) on or after 1 July 2024; or
- a worker who receives treatment at a public hospital emergency department on or after 1 July 2024;
 or
- a worker who receives treatment at a public hospital out-patient facility on or after 1 July 2024.

This table of costs outlines procedures, conditions and fees for the delivery of public hospital services in Queensland public hospital facilities, medical and allied health services provided to workers' compensation claimants. It applies only to workers' compensation claimants receiving treatment in the public hospital sector as a public patient under the care of a public hospital doctor.

This table of costs excludes claimants under the statutory workers' compensation system electing to be treated as private patients in private hospitals and all workers' compensation common law claimants. Fees for statutory workers' compensation claimants electing to be private patients in a public hospital are described in section 15 of this table of costs and documented in the Queensland Health Fees and Charges Register found at: Health Service Directives.

Note: The common law only patients are charged under compensable third-party fees when treated in the public hospital sector.

This table of costs is based on the Diagnosis Related Group (-DRG) casemix classification system v11.

This table of costs is structured to promote the provision of quality, timely and relevant treatment in the management of injured workers. In most cases, the rehabilitation goal is for a worker to return to work. In situations where the injury prevents the worker returning to work, rehabilitation must focus on maximising functional independence.

Health literacy for patients

Health literacy is about how:

- a worker accesses the relevant information about their health and healthcare
- a worker understands information about their health and healthcare, and
- they use the information to make informed decisions about their healthcare.

WorkCover Queensland (WorkCover) embraces the Australian Commission on Safety and Quality in Health Care position on <u>Health Literacy</u> and the <u>National Safety and Quality Health Service (NSQHS) Standards</u>.

WorkCover expects all providers who deliver services to Queensland workers to:

- make it easy for a worker to know where to go, what to do and how to find what is needed to improve
 their health and wellbeing, including information about their diagnosis, prognosis, processes, likely
 outcomes of possible tests and treatments and how prevent further injuries or illnesses
- make it easy for a worker to make better decisions about their health, wellbeing, and health care
- make it easy for a worker to manage their own health care, including treatment and medications
- help a worker to contribute to more effective decision-making and action about their own health care
- work in partnership with a worker so the worker can make informed and effective decisions



 help a worker reduce the risk of harm to themselves by providing thorough information that they can understand.¹

Supporting resources in relation to health literacy can be found on <u>the Australian Commission on Safety and</u> Ouality in Health Care website.

2. Working together

Insurers are committed to working with the Hospital & Health Services. If there is an issue in dispute, a Hospital & Health Service's representative should contact the relevant insurer to discuss an appropriate resolution. WorkCover offers each Hospital & Health Services, a dedicated relationship manager for the resolution of any issues.

3. Insurer's liability for services

The insurer's liability is subject to the Workers' Compensation and Rehabilitation Act 2003 (Qld).

The payment of services outlined in this document is subject to a worker having a compensation claim allowed by the Queensland workers' compensation insurer for the injury or condition being treated, i.e., WorkCover or a self-insurer, in accordance with the legislation. A list of insurers is available at: https://www.worksafe.qld.gov.au/insurance/find-a-self-insurer.

In all instances, a current 'Work Capacity Certificate – workers' compensation' is required to cover the period of service provision. If a worker does not have a certificate upon presentation to a public facility, a certificate may be issued by an emergency department or public hospital during the course of the treatment, or upon discharge.

Note: If there is no certificate, the insurer has no liability for the costs of treatment.

Due to the diversity of medical services and rehabilitation program content, there may be other expenses which are not covered in this document. These expenses are to be negotiated with the relevant insurer prior to the delivery of such services.

A public hospital is not strictly bound by the same 60-day invoicing restrictions as other providers; please consider the context of a claim and treatment when processing invoices outside these timeframes.

4. Definitions

Contracted hospital means a hospital that provides public health services to a patient under a contractual arrangement with the State, but does not include:

- a public sector hospital under the Health Services Act 1991 (Qld); or
- a Mater Misericordiae Public Hospital.

Note: In some situations, Hospital & Health Services enter arrangements with private hospitals to provide services for and on behalf of the Hospital & Health Services. These services will be billed by Hospital & Health Services under this table of costs.

Diagnosis Related Group (DRG) (also Australian refined, AR-DRG) is a casemix classification system used to group patients receiving inpatient services in a clinically meaningful way and reflecting similar resource usage.

Elective hospitalisation means hospitalisation involving treatment or a procedure decided on by a worker or the worker's doctor that is of advantage to the worker but is not fundamental in the treatment of the worker's injury.

Emergency department provides accident and emergency services in a public hospital. Often a patient of a public hospital may receive emergency department treatment prior to being admitted as an inpatient.

Facility fee is an applicable fee for treatment provided by a private specialist within a public hospital for specialised treatment that cannot be obtained elsewhere. Facility fees include costs such as room, accommodation and material.

Group X Hospital means a smaller rural or remote facility where inpatient fees are charged on a flat per day basis rather than the DRG model. See Appendix A.

Hospital includes a day hospital.

Hospitalisation of a worker means the admission of the worker in a private hospital or public hospital for medical treatment for the worker's injury.

Inpatient in a public hospital is a public patient admitted at a public hospital and includes admission as a public patient to a Mater Misericordiae Public Hospital or transfer to a contracted hospital.

Listed Hospital means a hospital in scope for charging emergency department services under the Public Health Services Table of Costs.

Non-X Hospital means larger hospitals identified as meeting the requirements for charging fees on a casemix/DRG or sub and non-acute (SNAP) basis. See Appendix A.

Out-patient in a public hospital is a public patient who is not admitted to a public hospital and receives treatment as an outpatient. The patient may have been an inpatient previously and is now receiving follow-up treatment as an outpatient.

Public hospital means a hospital to which a worker is admitted as a public patient.

Public patient means a patient who is not a private patient.

Private hospital means a hospital to which a worker is admitted as a private patient.

Private patient means a worker who is a patient of a private doctor at a hospital that is not a contracted hospital. The worker has elected to be treated as a private patient by a doctor of their choice, inclusive of patients treated privately at a public hospital.

Sub and non-acute (SNAP) care is specialised inpatient multidisciplinary or maintenance care.

5. Extent of insurer's liability

5.1 Where there is an 'at fault' driver (MAIC)

Under section 12(4) of the *Motor Accident Insurance Act 1994* (Qld) a levy is paid to cover the cost of providing public hospital services and emergency services:

- to people injured in a motor vehicle accident; and
- who use public hospital services and emergency services because of their injuries; and
- who are claimants or potential claimants under the compulsory third party (CTP) insurance scheme.

Further to these points, where the Motor Accident Insurance Commission (MAIC) is the liable agency;

 The workers' compensation insurer is only liable for the public hospital costs for injured workers not covered by the MAIC grant paid to Queensland Health to cover people injured in motor vehicle accidents.



- MAIC covers people injured in a motor vehicle accident in Queensland who are considered "not-at-fault" for the incident and where the "at-fault" person was operating a Queensland registered motor vehicle.
- The workers' compensation insurer can refuse payment of an invoice and notify the Hospital & Health Services that the invoice is rejected because there is an at fault driver and it is covered under the Motor Accident Insurance Act 1994.
- The workers' compensation insurer reserves the right to seek recovery of payments made to
 Queensland Health within the same financial year if it transpires that the cost is covered by a MAIC
 grant.

5.2 For artificial prosthesis (such as limb, arm or hand prosthetics)

For the provision of any artificial prosthesis, approval must be sought from the insurer prior to the prescription and fitting of the prosthesis.

5.3 For hospitalisation in a public hospital

An insurer's liability for public hospitalisation is outlined within section 218A of the *Workers' Compensation* and *Rehabilitation Act 2003* (Qld) and includes the provision of the facility as well as medical treatment provided at the hospital. The insurer must pay the cost of public hospitalisation, whether the public hospitalisation is provided at one time or at different times.

5.3.1. Non-elective hospitalisation

For non-elective hospitalisation an insurer will be liable for the cost of public hospitalisation for not more than four days. After this time, the insurer will be liable if the insurer considers the non-elective hospitalisation is reasonable having regard to a worker's injury. In determining what is reasonable, an insurer must have regard to the medical determination made by the worker's treating medical practitioner.

It is recognised that for non-elective hospitalisation, the Hospital & Health Services will provide services, in many cases before the worker has made a claim. Accordingly, an insurer will be making a retrospective assessment of the reasonableness of a stay of more than four days.

5.3.2. Elective hospitalisation

An insurer is liable for costs of elective hospitalisation to the extent it is agreed by the insurer under arrangements between the insurer and a worker (or someone for the worker) *before* the public hospitalisation. This includes sub and non-acute care fees.

5.4 Length of stay

The length of stay is calculated by subtracting the date the patient is admitted from the date of separation. All leave days*, including the day the patient went on leave are excluded. A day is measured from midnight to 23:59 hours and includes full and partial days. A patient admitted and separated on the same day (a "same day" patient) is allocated a length of stay of one day.

*A leave day is where a patient is away from a hospital overnight, e.g. to have a meal with family at Christmas.

6. Reports and information requests

Requests for reports from public hospitals are to be sent to the relevant information access email address of the hospital a worker attended. A hospital's Information Access area will not release specific reports regarding a patient. The insurer is required to request the complete file/patient records.

6.1 Discharge summary report

Public inpatient discharge summary reports are included in the cost of hospitalisation.



6.2 Other reports and communications

Other insurer requested reports or communications are subject to the WorkCover tables of costs for medical and allied health services.

6.3 Medical records

Insurer requested medical records will attract a fee from the public hospital. The fee will be based on the following:

Application fee: \$89.00

Processing fee: \$13.00 per 15 minutes

Copies of x-ray (film): \$30.00

Copies of photograph: \$14.00

Copies of videotape: \$34.00

Copy of audiotape: \$14.00

Copy of CD-ROM: \$34.00

PACS-Initial imaging study on CD media: \$142.00

PACS–Second and subsequent imaging study on CD media (per study): \$14.00

Copying charge of \$0.48 per page (A4 black and white only).

Note: These fees are GST exclusive.

The applicable WorkCover item number for insurer requested medical records for public hospitals is **400039**.

6.4 Worker's authority

If a hospital requires a signed authority from a worker to permit the release of medical records, the hospital may request an authority from the insurer. The insurer is permitted to provide the signature by email or facsimile.

6.5 Timeframes

A doctor attending a worker who has sustained an injury must give the insurer a detailed report on the worker's condition within 10 days of receiving the insurer's request to do so*. The fee payable to the doctor for the report is an amount accepted by the insurer to be reasonable, having regard to the relevant table of costs (please refer to the Supplementary Services Tables of Costs for General Practitioners and Specialists).

*Please refer to Section 104(4) of the Workers' Compensation and Rehabilitation Regulation 2014.

7. Fees

Queensland Health fees are established on a cost recovery basis and are based on the Independent Health and Aged Care Pricing Authority's (IHACPA) Annual National Hospital Cost Data Collection (NHCDC) reported cost

Queensland Health provides data to the national data set and the yearly increase is applied to the current prices. WorkCover will review any adjustments according to the IHACPA report and re-gazette a table of costs when appropriate.



Queensland Health operates many hospitals which are grouped according to the level of complexity and intensity of services offered, fees are calculated based on the services provided and the group the treating hospital is in. These hospitals and codes are detailed in Appendix A.

This Public Health Services Table of Costs outlines the fees an insurer can expect to be charged for services provided to injured workers. Insurers are also able to negotiate a fixed annual payment / agreement with the Queensland Health based on their estimated hospital costs separate to this table of costs if they wish.

8. Emergency department services

Emergency department charges for public workers' compensation patients include but are not limited to, the following services:

- Medical care provided by public hospital doctors
- Nursing care
- Pathology and imaging
- Theatre use, theatre consumables, in-theatre care and surgical implants
- Limited pharmaceutical and dressings may be included
- Allied health services
- Aids and appliances including those necessary for effective discharge-these may be loaned or given to the patient, depending on the facility
- Clerical and administrative support
- Discharge summary report, if available

Under Section 213(4) of the *Workers' Compensation and Rehabilitation Act 2003* (Qld), the 'Work capacity certificate – workers' compensation' must be free of charge. As such, medical certification is provided at no additional charge.

8.1 Emergency department definitions

Admitted patients are those that are admitted to the hospital directly from the emergency department, including those admitted as same day patients. Admission follows a clinical decision based on specified criteria that requires same-day or overnight care or treatment. The admission/transfer can be to a public hospital or a patient's home (for hospital-in-the-home patients).

Did not wait means a patient was triaged and registered however the patient did not wait to complete full treatment until clinical or administrative discharge occurred.

Died means a patient was "dead on arrival" at the emergency department or died whilst still considered to be under the care of the emergency department and was not admitted to the hospital. The fee for this service includes preparation of the body and transfer to the morgue.

Discharged patients are those discharged from the emergency department to home or to another facility of residence, other than an acute facility in a public hospital.

Transferred patients are those sent from the emergency department to any other acute facility (public, private, interstate or overseas) for continuation of their admitted care and management.

Triage means the assigning of degrees of urgency to decide the order of treatment. The triage category indicates the urgency of the condition and is defined according to national standards with triage 1 being the most urgent and triage 5 being the least urgent. (1=Resuscitation, 5=Non-urgent).

- the corresponding hospital code (Appendix A)

For example:

- A discharge-triage 3 (Emergency Department Item No. 99818) from the Princess
 Alexandra Hospital Emergency Department (Hospital Code 011) would have an item number of 99818011.
- A discharge-triage 3 from the Gold Coast University Hospital (Hospital Code 936) would have an item number of **99818936**.
- An admission-triage 5 (Emergency Department Item No. 99814) to the Gold Coast University Hospital would have an item number of 99814936.

8.2.2 Non-listed hospitals providing emergency treatment

Public hospitals not listed above should charge according to the WorkCover Medical Items Table of Costs. Please refer to: https://www.worksafe.qld.gov.au/service-providers/fees. When a patient is provided emergency treatment in a non-listed hospital and:

- then discharged, the medical items are charged for services provided.
- then subsequently admitted to the hospital on the same day. Hospitals can charge the items for the emergency treatment (as above) + the small hospital admitted day fee.

For example:

- A patient seen at the Richmond Emergency and received doctor's consultation, imaging, and treatment.
- The non-listed hospital would bill as per medical table of costs or MBS for these item numbers and if admitted to hospital as an inpatient following emergency room treatment, the hospital would then bill per day charge of 99800. The non-listed hospital can bill 99800 on the same day as emergency treatment as this is deemed day of admission.



9. Inpatient services

Inpatient fees for public workers' compensation patients include the following services:

- appropriate accommodation shared ward, or single room (if deemed clinically necessary), hospital hotel services, e.g., meals
- medical care provided by public hospital doctors
- nursing care
- pathology and imaging
- pre-operative and post-operative care whilst an inpatient in hospital
- theatre use, theatre consumables, in-theatre care and surgical implants
- all pharmaceutical and dressings. Discharge pharmaceuticals must be issued with a prescription and patient directed to obtain the medication from a private pharmacy not a public hospital pharmacy. Both the insurer and hospital should ensure workers are aware of this requirement.
- if a public hospital pharmacy inadvertently dispenses medication and raises charges on the patient for discharge medication, the patient can be reimbursed by the insurer
- allied health services
- discharge planning services
- aids and appliances including those necessary for effective discharge these may be loaned or given to a
 patient, depending on the facility
- clerical and administrative support
- discharge summary report.

Under Section 213(4) of the *Workers' Compensation and Rehabilitation Act 2003* (Qld), the 'Work capacity certificate – workers' compensation' must be free of charge. As such, medical certification is provided at no additional charge.

Note: Inpatient fees for public workers' compensation patients do not include emergency department fees. These are raised separately by the emergency department (see 8. Emergency department services).

9.1 Inpatient fee types

The Hospital & Health Services adopts a case mix-based pricing model for most acute public inpatients and a specified bed day fee for other types of public patients.

Admitted services are costed according to the hospital category and the patient diagnosis. There are four categories of inpatient fee types:

- Small hospitals (Group X Hospital) handle acute, sub-acute and non-acute
- Sub and non-acute (Non-X Hospitals)
- Acute (Non-X Hospitals)
- Hospital in the home (HITH)



9.1.1 Small hospitals

9.1.1.1 Small hospitals - Group X hospital fees

These are smaller facilities in rural and remote areas. Treatment provided in these facilities is charged on a per day fee basis irrespective of the diagnosis category or the type of treatment. For all inpatient admissions the invoice will multiply the number of days by the per day fee for that day. This applies to acute, sub-acute and non-acute types of care.

Note: Because treatment in small hospitals (Group X) is based on a flat fee per day, the item number is not based on a DRG code.

9.1.1.2 Small hospitals - Group X hospital item numbers

The WorkCover item number for small hospitals is based on two components:

- the Small Hospital Item No. (listed in the table above); and
- the corresponding Hospital Code (Appendix A)

Small Hospital Item No. + WorkCover Hospital Code

For example:

- Inpatient admission and all treatment provided at the Biloela Hospital (Hospital Code 133) would have an item number of 99800133.
- Inpatient admission and all treatment provided at the Tully Hospital (Hospital Code 227) would have an item number of 99800227.

9.1.2 Sub and non-acute care – Non-X Hospitals

9.1.2.1 Sub and non-acute care fees

Some types of treatment that a patient may receive are not considered "acute". These types of care include rehabilitation, palliative care, and maintenance care. The following fees and item numbers are for sub and non-acute care provided by hospitals in categories non-X hospitals.

- the corresponding Hospital Code (Appendix A)

Sub and Non-Acute Item No. + WorkCover Hospital Code

For example:

- Rehabilitation-Same Day (Sub and Non-Acute Item No. 99802) provided at the Princess Alexandra Hospital (Hospital Code 011) would have an item number of 99802011.
- Rehabilitation-Same Day provided at the Gold Coast University Hospital (Hospital Code 936) would have an item number of **99802936**.
- Palliative care (Sub and Non-Acute Item No. 99804) provided at the Gold Coast University Hospital would have an item number of 99804936.

9.1.3 Acute care - Non-X Hospitals

9.1.3.1 Acute care fees -

Patients receiving acute care in Non-X Hospitals have their fees calculated under a casemix basis. This type of fee relates specifically to the condition for which a patient was treated and for how long they were treated. The casemix fee for a public hospitalisation will be determined by three key elements:

- Hospitalisation category with its relevant base rate;
- Diagnosis category (DRG code) the type of condition as described by the
 Diagnosis-Related Group with its applicable cost weighting; and
- Length of stay (LOS) a worker's length of stay in hospital compared and adjusted to the average for that DRG via "trim points".

The average length of stay and "trim points" have been calculated for each diagnosis category (DRG code). The average length of stay and cost weighting may vary between hospital groups.

9.1.3.2 Base rates

9.1.3.5 Trim points

The trim points are calculated based on the L3H3 trimming method as follows:

- **Low trim point** - The calculation is LOS/3.

Note: The distribution for most DRGs is so skewed that the low trim point is usually just one day. For these DRGs there will be no short stay outliers.

- **High trim point** The calculation is LOS x 3.
- Extra high trim point The calculation is LOS x 4.5.

9.1.3.6 Formulas

Depending on where the length of stay falls in relation to the trim points, there are four different formulas which may be used to calculate the case mix fee.

A calculator has been prepared to assist in the determination of acute inpatient fees utilising the following formulas. This can be found here.

A. Inlier – length of stay falls between the low and high trim points (inclusive)

Inlier fee = DRG cost weight x Base rate

B. Short stay outlier - length of stay falls below the low trim point

Fee = the <u>lesser</u> of:

Inlier fee

OR

(Actual LOS /Low trim point) x Inlier fee but not less than 75% of Inlier fee

C. **Long stay outlier** – length of stay is above the high trim point and less than or equal to the extra high trim point. The long stay per day rate applied is dependent on the DRG type (medical or intervention)).

Fee = Inlier fee + [(Actual length of stay - High trim point) x Long stay per day rate]

D. **Extra-long stay outlier** – length of stay is anywhere above the extra high trim point

Fee = Inlier fee

- + [(Extra high trim point High trim point) x Long stay per day rate]
- + [(Actual length of stay Extra high trim point) x Extra-long stay per day rate]



Fee example:

Mary suffers severe burns at work and is admitted to the Royal Brisbane Women's Hospital. The diagnosis category is Y61Z, with a length of stay of 3 days. The insurer should receive an invoice from Hospital & Health Services which would show an item number of 99650201* with a fee of \$10,161.78.

The following is an extract from the Hospital & Health Service Public Hospital Cost Benchmarks for DRG code Y61Z. Non-X Hospitals

Inlier formula: Fee = DRG cost weight x Base rate

- = 1.37** x \$7,395 (Non-X Hospital base rate)
- = \$10,161.78

If Mary had required 15 days hospitalisation, this would be classified as a "long stay outlier". The fee for this stay is calculated by using the inlier cost benchmark to cover the stay until the "high trim point" and a "long stay" per day rate applies for the days between the "high" and "extra high" trim points- which in this example is one day at the long stay per day rate. Therefore, the fee would be:

Fee = Inlier fee + (Actual length of stay - High trim point) x Long stay per day rate

- = \$10,161.78 (Inlier fee) + ((15-11) x \$2061)
- = \$10, 161.78 + \$8,244
- = \$18,405.78

9.1.3.7 Acute care fee verification - Non – X Hospitals

The insurer may verify individual charges for acute care on the Hospital & Health Service invoice by using WorkCover's *Queensland Health Public Patient Acute Inpatient Cost Check*. Please note that the verification calculator will not verify sub and non-acute care charges as these are per day rates as per page 12. (https://www.worksafe.qld.gov.au/service-providers/medical-fees)

9.1.3.8 Acute care item numbers - Non - X Hospitals

The WorkCover item number for acute care is based on two components:

- The Australian Refined-DRG classification code; and
- The corresponding hospital code (see Appendix A).

Each **DRG code** has been allocated a WorkCover DRG Item Number (See appendix B).

^{**}For the above example, the Cost Weight has been rounded to the nearest two decimal points. The Acute Inpatient Cost calculator maintains the true value of decimal places. Please refer to the Acute Inpatient Cost Calculator for confirmation of fees.

9.2 Hospital in the home (HITH)

Hospital in the home (HITH) is the provision of care (including acute, palliative, mental health and rehabilitation services) to patients in the comfort of a person's own home or other suitable environment. Patients are regarded as hospital inpatients and remain under the care of their hospital doctor. Care may be provided by a nurse, doctor and/or allied health professional. Additional home supports can be arranged as required. HITH is an alternative to a hospital inpatient stay. Patients can be offered this option by treating staff if the care type can be delivered safely at home. Research findings demonstrate that patients have improved outcomes and recovery at home with fewer complications such as infection. Participation in HITH is voluntary - patients and insurers must agree and approval be given to have the care provided at home. This is charged as a per day fee.

9.2.1 Hospital in the home item numbers – All hospital groups

The WorkCover item numbers for HITH care are based on two components:

- HITH Item No. (listed in the table above); and
- The corresponding Hospital Code (see Appendix A)

HITH Item No. + WorkCover Hospital Code

For example:

 HITH Item No. 99806 provided by the Princess Alexandrea Hospital (Hospital Code 011) would have an item number of 99806011.



10. Interfacility transfer costs and escort fee item number

This item is for transfer to and from hospital and can include one or more of the following – escort, paramedic, and ambulance fees. This item does not cover transportation from a hospital to a patient's home.

Note: The Workers' Compensation Regulator's QAS grant covers pre-hospital care but does not cover inter-facility transfers.

11. Outpatients

Providers in the Hospital & Health Services' outpatient clinics are to utilise the WorkCover tables of costs for **medical practitioners and allied health providers**, relevant to the service provided:

- Medical Items Table of Costs
- General Practitioner Supplementary Services Table of Costs
- Specialist Supplementary Services Table of Costs (treating specialists, physicians and psychiatrists)
- Nursing services
- Dental services
- Occupational therapy services
- Physiotherapy services
- Hand therapy services
- Podiatry services
- Mental health services
- Speech pathology services

The Hospital & Health Services do not provide Chinese medicine, chiropractic, exercise physiology or osteopathy services.

These tables of costs may be obtained from the website under Service providers > <u>Medical or Allied Health</u> <u>Fees.</u>

For any services not described under a table of costs, the provider should seek prior approval from the insurer.

For all presentations, a charge will be applied to each occasion of service. There may be occasions where multiple presentations will occur for one condition and on one day (e.g. a physiotherapy and psychology consultation on the same day). Each treatment will be charged individually.

Prior insurer approval may be required for more than one consultation with the same provider on the one day. Reference should be made to the relevant table of cost for further information.



12. Pharmaceuticals

Workers' compensation patients who require prescription medication must be issued with a prescription and directed to obtain the medication from a private pharmacy not a public hospital pharmacy. Both the insurer and hospital should ensure workers are aware of this requirement. If a public hospital pharmacy inadvertently dispense medication and raises charges on the patient for outpatient medication, the patient can be reimbursed by the insurer.

Exemptions to the above – if a patient is prescribed a restricted medication only available through a hospital pharmacy (e.g. certain IV drugs or medications only available under a special access scheme) the hospital may claim these costs from the insurer.

13. Nursing services

Nurses who provide outpatient and emergency nurse services only should use items in the <u>Nursing Services Table of Costs</u>.

14. Cast technicians/plaster orderlies

Cast technicians who provide outpatient services can charge for the consultation and resources required. Services that are provided in an emergency department or whilst the worker is an inpatient are not billable. The Hospital & Health Services can only charge a cast technician fee and associated incidental charges can only be billed if the treating technician holds a Certificate IV in Cast Technology (HLT41412 or HLT41407), only if issued prior to 13 June 2017 or a Diploma of Orthopaedic Technology (HLT57821).
